ADDITIONAL INFORMATION- Danny Robinson Memorial Jr. Required Family Hunt

This is a 2-day hunt! Juniors will hunt on Saturday and then again on Sunday along with their guests. Maximum hunt party size is 2 on Saturday and 4 on Sunday. Please arrive on time for check-in and pre-hunt registration, which is 9 a.m. There is no cost to participate. Hunters must possess a valid 2023-2024 California hunting license and upland game bird stamp. Hunters possessing a junior hunting license do not need an upland game bird stamp and must be accompanied by a non-shooting adult 18 years of age or older. All shooters and non-shooters must wear shooting safety glasses, blaze orange and initial and sign the enclosed waiver.

Please come prepared and wear appropriate gear for the hunt; we strongly recommend you bring water, a hat, sturdy shoes/boots, sweater/jacket, mosquito repellant and a cooler with ice for your birds. **The hunt will be held rain or shine, so please be prepared**. For safety, Apprentice hunters must have a properly fitted shotgun.

As of July 1, 2015, NONLEAD AMMUNITION is required when hunting on ALL CDFW Lands.

As of July 1, 2016, NONLEAD Ammunitions required when taking upland game birds with a shotgun, except for dove, quail, snipe and any game birds taken on licensed game bird clubs.

Please plan accordingly.

Please bring **Non-Lead** low-base or high-base shot shells size 4, 5, 6, or 7 ½ shot only. Contact the hunt leader for that particular site prior to the hunt event for guidance. No magnum loads are allowed. Junior hunters may have **only one shot shell** in the magazine or chamber while hunting. **No shotguns with exposed hammers will be allowed on this hunt**. Please note: if you are not prepared for the hunt or your gear is deemed unsafe you may be asked to withdraw from the hunt. Please remember to bring your own food and drinks, and water for your dog. Also, there are no restrooms once you leave the check-in location.

You may bring your own hunting dog. You must obey hunter etiquette and maintain control of the dog. If your dog will not perform well around other dogs then it is best to leave the dog at home. Several volunteers with trained hunting dogs may be available to assist the hunting groups. Please leave your dog and your weapon in your vehicle until after the hunter orientation and assignment to the hunting field.

MONITOR AND JUNIOR HUNTER SAFETY INFORMATION

The purpose of a junior hunt is to give young hunters the opportunity to hunt game in a more relaxed atmosphere and to provide them with a greater chance to bag game.

Of utmost importance is **SAFETY**. Safety is stressed at ALL times. Safety is more important than bagging game.

JUNIOR HUNTERS - Now is the time to show everything you have learned in your hunter education class!

SAFETY MONITOR - Please ask a few questions of the group:

- What do you mean by "zone of fire"?
 - The space or area into which a hunter may safely shoot.
- In what position should you keep the firearm safety while hunting?
 - o In the "on" position until you have shouldered your gun and are pointing at your target. Never put your finger on the trigger until you are ready to shoot.
 - o Remember, you are the best safety. Do not rely upon the gun's safety because it could fail to work. Always keep the firearm pointed in a safe direction.
- How do you know if the firearm is loaded or unloaded?
 - You must personally check it yourself. Never take <u>any</u> person's word for it check it yourself.
- If you stumble or fall, when you get up what is the first thing you should do?
 - o Check and make sure the gun is emptied and then check the barrel.
- When you do fall, what is the most important thing to do?
 - Hang on to your firearm to control the muzzle and make sure it is pointing in a safe direction.

The field you are going to hunt has been pre-planted with several pheasants. TAKE YOUR TIME. Pheasants love to hide. We want you to take at least an hour to make 2 passes through the field.

Be aware of where you are in relation to other in the group. STAY IN LINE!

If you, your dog, or accompanying adult get in front of the line and create a safety hazard, you will be asked to leave the field.

Your dog or dogs must be under control at all times. NO EXCEPTIONS! If your dog is not under control, the dog must be taken from the field by its handler.

REMEMBER, HAVE FUN, STAY IN LINE AND KEEP IT SAFE! GOOD LUCK!

The Ten Commandments of Firearms Safety:

- 1. Watch that muzzle! Keep it pointed in a safe direction at all times.
 - 2. Treat every firearm with the respect due a loaded gun.
- 3. Be sure of your target and what is in front of it and beyond it.
- 4. Keep your finger outside the trigger guard until ready to shoot .
 - 5. Check your barrel and ammunition.
 - 6. Unload firearms when not in use.
 - 7. Point your firearm only at something you intend to shoot.
 - 8. Don't run, jump, or climb with a loaded firearm.
 - 9. Store firearms and ammunition separately and safely.
- 10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.






