Cosco Busan Trustee Council Resolution Regarding Disbursement of Funds for Restoration Projects for Fiscal Year 2012

- 1. The State of California, acting through the Department of Fish and Game (CDFG) and the California State Lands Commission (CSLC); the National Oceanic and Atmospheric Administration (NOAA); and the Department of the Interior (DOI), acting through the U.S. Fish and Wildlife Service (USFWS) and the National Park Service (NPS), are the trustees responsible for restoring those natural resources injured by the discharge of oil from the *M/VCosco Busan* on November 7, 2007.
- 2. Sums recovered in the civil action United States v. M/V Cosco Busan et al., and related actions, are being held in the DOI Natural Resource Damage Assessment and Restoration Fund (NRDAR Fund) and the San Francisco Bay Shoreline Parks and Recreational Use account established by the National Fish and Wildlife Foundation (NFWF Rec Account).
- 3. The Trustees have entered into a Memorandum of Understanding (MOU) among themselves for the purpose of coordinating their trust responsibilities.
- 4. The MOU specifies several procedural prerequisites to the implementation of projects selected in the Restoration Plan. Among other things, a selected project may not proceed unless a lead Trustee has been designated for that project and the Trustee Council has given its written authorization to commence the project.
- 3. The MOU further requires the Trustee Council to memorialize all expenditures of funds from the above-referenced accounts in a Trustee Council Resolution signed by the participating voting members. The settlement funds may only be used for the design, implementation, permitting (as necessary), monitoring and oversight of restoration projects and for the costs of complying with the requirements of law to conduct a restoration planning and implementation process. The use of such funds must be documented and an accounting provided to the Cosco Busan Trustee Council.
- 4. The Trustee Council hereby authorizes the disbursement of the following funds (totaling \$690,321) from the NRDAR Fund for the implementation of certain restoration projects, as described in the Cosco Busan Damage Assessment and Restoration Plan/Environmental Assessment:
 - \$605,248 to the USFWS for implementation of the Aramburu Island Shoreline Protection and Ecological Enhancement Project;
 - \$72,503 to CDFG for implementation of the Marbled Murrelet Restoration Project. Said funds are to be transferred to California Department of Parks and Recreation PCA 89520, on behalf of CDFG; and
 - \$12,570 to CDFG for implementation of the Marbled Murrelet Restoration Project.

- 5. This Resolution may be executed in counterparts. A copy with all original executed signature pages affixed shall constitute the original Resolution and be retained by the Lead Administrative Trustee that maintains records.
- 6. The effective date of this resolutio shall be the date on which the last Trustee Signs this resolution.
