On July 28, 2023, the Fish and Game Commission (Commission) provided notice of its intent to amend Section 632, Title 14, California Code of Regulations (CCR), concerning pre-existing structures in marine protected areas and marine managed areas. On November 13, the Commission provided notice of its intent to amend sections 250, 251.5, 252, 257.5, 258, 350, 352, 353, 401, 465.5, 679, 708.13, add sections 375, 376, 377, 378, 379, and repeal Section 368, Title 14, CCR concerning exotic game mammals and wild pig validations and to amend Section 28.15, Title 14, CCR, concerning recreational California halibut regulations updates.

At the time the notices were published, the location for the December 13-14, 2023 Commission meeting had not yet been determined.

At a meeting to be held on December 13-14, 2023, at 8:30 a.m., or as soon thereafter as the matter may be heard, the Commission will consider the following actions:

#### **Consider adopting:**

- Pre-existing Structures in Marine Protected Areas and Marine Managed Areas

#### **Discuss:**

- Exotic Game Mammals and Wild Pig Validations
- Recreational California halibut regulations updates
