This is to provide you with a notice of sufficiently related changes to the proposed Department of Fish and Wildlife lands regulations, published in the California Regulatory Notice Register on December 1, 2023, Notice Number Z2023-1121-03, and scheduled for adoption by the California Fish and Game Commission (Commission) on February 15, 2024.

Because these regulations are different from, yet sufficiently related to, the originally proposed regulations, the Administrative Procedure Act (APA) requires that we make these changes available to you for a written comment period.

The revised proposed regulations relate to criteria for posting areas allowed for use of electric bicycles [subsection 550(c)(4), Title 14, California Code of Regulations (CCR)] found on page 1 of the attached revised proposed regulatory language for Section 550, Title 14, CCR; and hunting on Burton Mesa Ecological Reserve [subsection 630(d)(7), Title 14, CCR], found on page 3 of the attached revised proposed regulatory language for Section 630, Title 14, CCR.

The proposed changes are clearly indicated on the attached revised proposed regulatory language as follows: Language originally proposed to be added is shown in <u>underline</u>. Language originally proposed to be deleted is shown in <u>strikeout</u>. Language originally proposed to be added but now proposed to be removed is shown in <u>underline/double strikeout</u>. Language newly proposed to be added is shown in double-underline.

Pursuant to APA requirements, we are providing you with the full text of all sections of the originally proposed regulatory language; however, there are no revisions to the originally proposed regulatory language in sections 540 and 551, Title 14, CCR.
