 - CVP: Trinity River release is 300 cfs. Sacramento River (Keswick) release is 5,000 cfs. Clear Creek (Whiskeytown) release is 200 cfs. American River (Nimbus) release is 2,000 cfs. Stanislaus River (Goodwin) release is 200 cfs. Reclamation's

Delta pumping is at 4 units, targeting 3,600cfs. Federal share of San Luis Reservoir is 732 TAF.

- SWP: Feather River (Oroville-Thermalito Complex) releases are 1,750 cfs. Clifton Court Forebay exports are 2,000 cfs. State share of San Luis Reservoir is at 419 TAF.
- Hydrology Update (DWR and Reclamation): Seeing multiple systems moving in with heavy rains predicted in the 6-day-forecast, tapering out by next Wednesday (12/20/23). With these systems heavy rainfall is expected throughout most of California, minus the South-Eastern area of the state. The forecast is predicting 2 inches in the San Francisco Bay, ½ inch in Monterey, ½ inch in Eureka, up to 2 inches in Redding and the Sierras, and ½ to 1 inch in the Sacramento Valley.
