  - CVP: Trinity River release is 300 cfs. Sacramento River (Keswick) release is 15,000 cfs. Clear Creek (Whiskeytown) release is 200 cfs. American River (Nimbus) release is 1,750 cfs. Stanislaus River (Goodwin) release is 1,500 cfs. Reclamation's Delta Pumping is at 3

units targeting 2,700 cfs. On Saturday (2/3/24) will increase to 4 units targeting 3,600 cfs. Federal share of San Luis Reservoir is 842 TAF.

- SWP: Feather River (Oroville-Thermalito Complex) releases are 12,000 cfs. Clifton Court Forebay exports are 1,100 cfs. State share of San Luis Reservoir is at 397 TAF.
- Hydrology Update (DWR and Reclamation):
  - The 6-day forecast is predicting 3-4 inches in the Sacramento valley, 4-6 inches along the Sierras, 6-8 inches in norther California. These earlier storms are warmer but are expected to cool down and build up snowpack. Currently, California is below average for precipitation and snowpack.
