Disaster Relief Steps - In Progress

CDFW preparing Spending Plan with **public input** by **March 29, 2024**

□ Submit Spending Plan by April 12, 2024

□ Spending Plan Approval

□ Fund award released with disbursement through Pacific States Marine Fisheries Commission (PSMFC)

- Applications sent via PSMFC
- No money will be available until January 1, 2025

California Department of Fish and Wildlife (CDFW)



Address range of fishery impacts

Encourages use of funds for MITIGATION (activities that restore the fishery or prevent a similar future failure)

Assist fishing communities affected by failure

Strengthen long-term economic and environmental sustainability of the fishery (e.g., habitat restoration, research, capacity reduction, etc.) Emphasis on funding MITIGATION

If direct payments to divers and businesses, use the most simplified calculation possible

- Ensure better chances for approval by PSMFC/NOAA
- Will help streamline the spending process and expedite payments

More Money Going to Direct Payments for Divers/Buyers

Department Seeking Feedback On....

- 1. Percentages to mitigation (20%) and direct payment (79%)
- 2. Qualification Criteria
 - Minimum poundage requirement (1,000 lbs. cumulative over 5 years)
 - Qualification years (2013-2017)
- 3. Disbursement Options
 - Fishermen (66%)
 - Weighted by Tier
 - Processors (34%)
 - Proportional by landings
- 4. Mitigation/Restoration Themes

- Potential Eligible Permittees, Individuals and Businesses:
 - Ensure that CDFW contact information is up to date in permitting/licensing database. Marine Region staff can verify information, but individuals **must** contact License and Revenue branch staff to update information.
- Deadline to submit comments on CDFW's proposed spending plan is March 29, 2024
