ADDITIONAL INFORMATION

Hunters must have a valid/current California hunting license. Junior hunters do not need an Upland Game Bird validation. A junior hunter must be accompanied by a non-shooting adult 18 years of age or older. All shooters and non-shooters must wear shooting/safety glasses, blaze orange, and initial and sign a waiver (enclosed), for the hunt.

Nonlead ammunition is required when taking any wildlife with a firearm anywhere in California. Please plan accordingly.

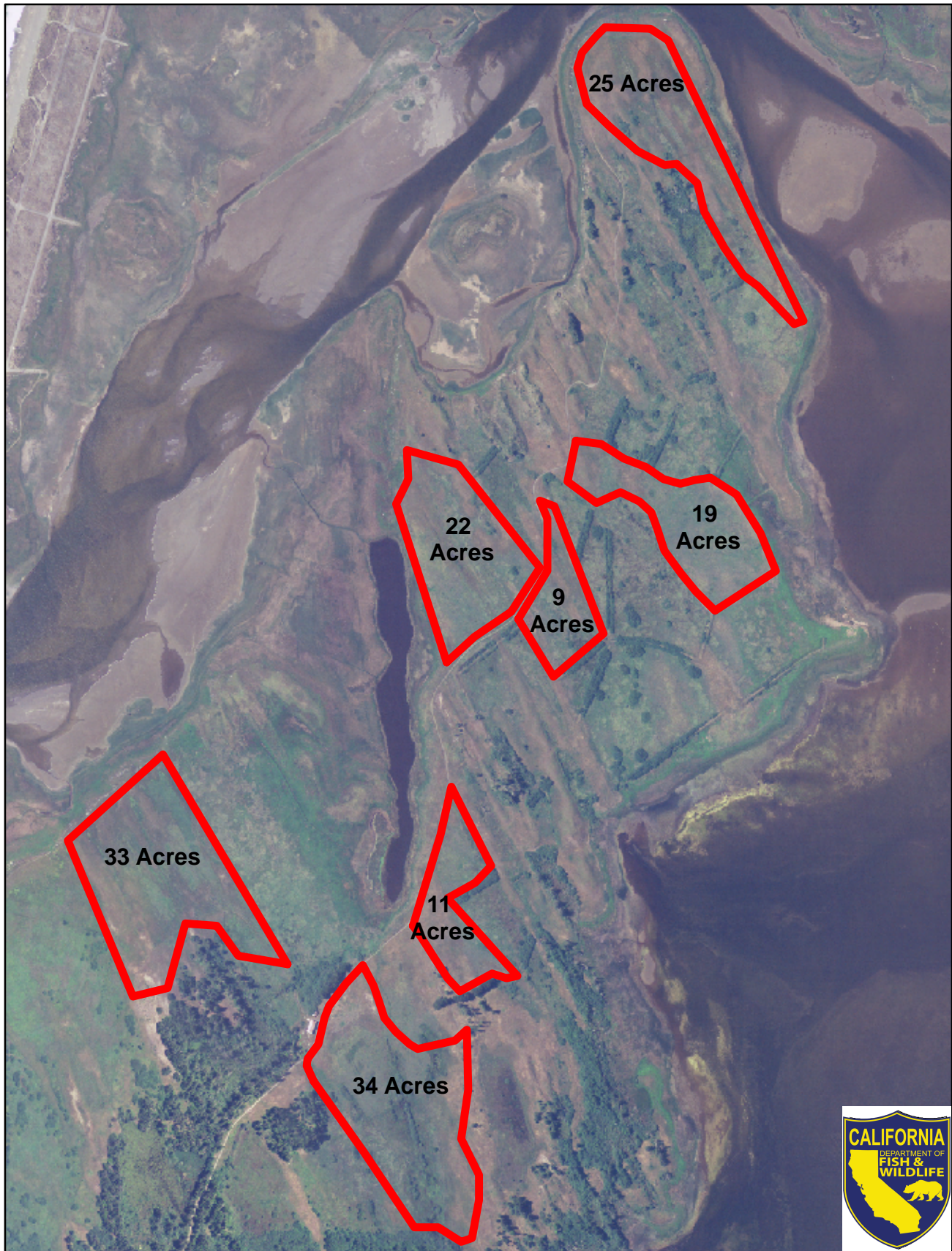
Hunters need to meet at the entrance gate at Lake Earl Wildlife Area on Old Mill Road in Crescent City. Hunters will be greeted at gate and allowed to proceed to hunt meeting area inside the Wildlife Area once firearms and ammunition are inspected for safety. Please arrive with firearms unloaded and readily available. Safety gear will be provided for hunters to include blaze orange safety vests and eye protection on a loan basis. However, failure of the Department to have these items available for loan does not relieve the Hunt Participant from using these items. Please bring a folding chair as seating may be limited. Waters, drinks, and food are being provided by the local McDonalds and volunteers, however if you need or desire additional snacks bring them. Please prepare for changing weather, It could be hot, foggy, cool, wet, windy, etc. Dress accordingly and bring a hat, sunscreen, jacket, etc.

This hunt was made possible by the purchases of the Upland Game Bird Stamp. Practice good sportsmanship, be a safe hunter and most of all enjoy your hunt. The Ten Commandments of Firearms Safety:

1. Watch that muzzle! Keep it pointed in a safe direction at all times.
2. Treat every firearm with the respect due a loaded gun.
3. Be sure of your target and what is in front of it and beyond it.
4. Keep your finger outside the trigger guard until ready to shoot .
5. Check your barrel and ammunition.
6. Unload firearms when not in use.
7. Point your firearm only at something you intend to shoot.
8. Don't run, jump, or climb with a loaded firearm.
9. Store firearms and ammunition separately and safely.
10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.

Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree to assume the risk that I may be seriously injured or killed through the negligent acts of others. I agree to waive any right I may have to sue the State, its agents, employees and/or volunteers for injuries or death that I may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. _____.
