Pursuant to the requirements of California Government Code Section 11346.8, subdivision (c), and Section 44 of Title 1 of the California Code of Regulations, the California Fish and Game Commission is providing you with a notice of sufficiently related changes to the proposed regulations concerning marine logbooks and fishing block charts, published in the California Regulatory Notice Register on May 31, 2024, Notice No. Z2024-0517-01, and adopted by the California Fish and Game Commission (Commission) on August 14, 2024.

This notice provides notification of a revision to the proposed amendments to the regulatory language in Section 190, Title 14, California Code of Regulations (CCR).

Because these regulations are different from, yet sufficiently related to, the originally proposed regulations, the Administrative Procedure Act requires that we make these changes available to you for a fifteen-day written comment period.
