- CVP: Trinity River release is 300 cfs. Clear Creek (Whiskeytown Dam) release is at 200 cfs. Sacramento River (Keswick) release is 4,800 cfs and will be going down to minimum flow of 4,000 by November 17. American River (Nimbus) release is 2,000 cfs. Stanislaus River (Goodwin) release is 200 cfs. Reclamation's Delta export is currently 4 units which is approximately 3,500 cfs. Federal share of San Luis Reservoir is 343 TAF. Delta Cross Channel Gates closed yesterday and will open this Friday.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,750 cfs. Clifton Court Forebay exports are at 1,200 cfs. State share of San Luis Reservoir is 702 TAF.
