- Operational Updates
  - CVP: Current Trinity River release is 2,000 cfs, with a pulse flow scheduled from March 21<sup>st</sup> to April 15<sup>th</sup>. Clear Creek (Whiskeytown Dam) release is 275 cfs. Sacramento River (Keswick) release is 15,000 cfs. American River (Nimbus) release is 2,000 cfs, with reductions to 1,500 cfs and 1,350 cfs scheduled for tomorrow and Friday, respectively. Stanislaus River (Goodwin) release is 600 cfs, decreasing to 200 cfs Friday. Jones PP Delta exports are at 4,200 cfs. Federal share of San Luis Reservoir is 757 TAF. Delta Cross Channel Gates are closed and will remain closed until May, unless there is a water quality issue.
  - SWP: Feather River (Oroville-Thermalito Complex) releases are at 15,000 cfs and holding for now. Clifton Court Forebay exports are at 3,100 cfs. State share of San Luis Reservoir is 1.011 MAF.
- Hydrology Update
  - Scattered rain and mountain showers today and tomorrow. Predominantly dry weather expected into early next week with gradually warming temperatures.

- Update: SWT was informed that the Stanislaus River irrigation districts are considering a 2025 water transfer of up to 100 TAF.
- Update: Recent natural origin winter-run loss is approaching the weekly distributed loss threshold.
- DWR:

## Discussion Items

- Reclamation noted that the 100% annual threshold for hatchery winter-run salvage (CWT) fish for 2025 is 162 fish, with the corresponding 50% annual threshold salvage at about 80 fish.
- The current salvage count is about 73 fish, so 1-4 more hatchery winter-run salvage at export facilities could trigger an exceedance of the 50% threshold, and an operational export restriction for seven days of an OMRI no more negative than -3,500 cfs.
- SaMT's proposal (as detailed in Crystal Rigby's 3/19/25 email to WOMT) for the 2<sup>nd</sup> YOY spring-run surrogate release group was approved by WOMT.

- Mike Ford (acting as WOMT facilitator) will send out an email notifying SaMT of WOMT's approval of the 2<sup>nd</sup> YOY spring-run surrogate release proposal with cc's to WOMT members.
