- Operational Updates
  - CVP: Current Trinity River release is 1,700 cfs, with a pulse flow scheduled from March 21<sup>st</sup> to April 15<sup>th</sup>. Clear Creek (Whiskeytown Dam) release is 275 cfs. Sacramento River (Keswick) release is 8,500 cfs. American River (Nimbus) release is 1,350 cfs. Stanislaus River (Goodwin) release is 200 cfs. Jones PP Delta exports are at 3,500 cfs. Federal share of San Luis Reservoir is 804 TAF. Delta Cross Channel Gates are closed and will remain closed until May, unless there is a water quality issue.
  - SWP: Feather River (Oroville-Thermalito Complex) releases are at 11,000 cfs. Clifton Court Forebay exports are at 2,000 cfs. State share of San Luis Reservoir is 1.012 MAF.
- Hydrology Update: The weather will undergo a transformation from drier and warmer
  conditions to cooler and more unsettled weather tonight. A more active pattern bringing
  widespread rain, snow and winds is expected to move into Northern California Sunday
  night. Chances of rain and snow increase with this pattern, but confidence in model
  predictions remains low.
