

Description of Specific Edits to the Regulatory Text

Section 7.40(b)(4)(B): Indicate that the static season date of July 16 through October 31 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon.

Section 7.40(b)(4)(C): Indicate that the static season date of July 16 through December 31 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon.

Section 7.40(b)(4)(D): Indicate that the static season date of July 16 through December 16 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon.

Section 7.40(b)(43)(D): Indicate that the static season date of July 16 through October 31 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon.

Section 7.40(b)(43)(E): Strike out the word “mouth” so that the first column reads “From 200 yards above Live Oak boat ramp to the Highway 99 bridge” and strike out “For purposes of this subsection... Verona Marina boat ramp.”

Section 7.40(b)(43)(E): Indicate that the static season date of July 16 through December 16 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon.

Section 7.40(b)(43)(F): Add a new subsection (F) to create a new segment of the Feather River defined as “From the Highway 99 bridge to the mouth. For purposes of this subsection, the lower boundary is defined as a straight line drawn from the peninsula point on the west bank to the Verona Marina boat ramp.”

Section 7.40(b)(43)(F): In the new subsection (F), indicate that the bag and possession limits, seasons, and proposed regulatory options are identical to those in subsection (E).

Section 7.40(b)(66)(A): Indicate that the static season date of July 16 through October 15 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon

Section 7.40(b)(66)(B): Indicate that the static season date of July 16 through December 31 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon

Section 7.40(b)(66)(D): Indicate that the static season date of July 16 through December 16 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon

Section 7.40(b)(80)(C): Indicate that the static season date of August 1 through October 31 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon and that the static season date of November 1 through December 31 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon

Section 7.40(b)(80)(D): Indicate that the static season date of July 16 through December 16 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon

Section 7.40(b)(80)(E): Indicate that the static season date of July 16 through December 16 is still applicable to hatchery trout and hatchery steelhead, while the proposed flexible date range applies to Chinook salmon
