### TO ALL INTERESTED AND AFFECTED PARTIES:

Pursuant to the requirements of California Government Code Section 11346.8, subdivision (c), and Section 44 of Title 1 of the California Code of Regulations, the California Fish and Game Commission (Commission) is providing you with a notice of sufficiently related changes to the proposed regulations concerning Central Valley Sport Fishing, published in the California Regulatory Notice Register on March 28, 2025, Notice No. Z2025-0318-01.

The Commission is providing notice of revisions to the proposed amendments to the regulatory language in Section 7.40(b)(4), (b)(43), (b)(66), and (b)(80), Title 14, California Code of Regulations (CCR).

Because these regulations are different from, yet sufficiently related to, the originally proposed regulations, the Administrative Procedure Act (APA) requires that we make these changes available to you for a minimum fifteen-day written comment period. The proposed changes to the regulations are clearly indicated on the attached revised proposed regulatory language as follows: additions of newly proposed language are shown in double underline; originally proposed language that is now proposed for deletion is shown in ~~single underline double strikeout~~; originally proposed language in sections being amended, not affected by the changes described in this notice, is indicated in single underline.

Pursuant to APA requirements, we are providing you with the full text of all sections of the originally proposed regulatory language.

Please refer to the attached description of the specific edits to the proposed regulatory language.
