WCB in 2024

WCB contributed to 120 projects for the 2024 calendar year, allocating approximately \$320 million in funding including:



\$93.5 million for habitat restoration and enhancement of over **5,000 acres**



\$162.4 million for purchase or conservation easement on **90,000 acres of land**



\$63.9 million for public access, project planning, and studies



WCB Climate Bond Funding Categories

- Protect and Enhance Fish & Wildlife Resources and Habitats and Achieve Biodiversity, Public Access, and Conservation Goals \$668M
- Habitat Connectivity and Wildlife Crossings and Corridors \$100M
- Stream Flow Enhancement \$100M
- Fish Habitat Enhancement and Restoration Program \$50M
- **New** San Andreas Corridor Program \$80M
- Lower American Conservancy \$10M
- Southern Ballona Creek Watershed \$22M





FY 2025/2026 (proposed):

- Protect fish and wildlife/biodiversity: \$176M
- Wildlife crossings and corridors: \$21M
- Streamflow: \$21M
- Fish habitat enhancement: \$11M
- Lower American River Conservation Program: \$3M



WCB Grants

- Continuously open, rolling application process
- Open to: non-profit organizations, government agencies, federally recognized tribes
- Approved at four board meetings per year

WCB Grant Process





Acquisition Process

- Fund Source
- Consult with WCB!
- CDFW priorities are important
- Project Manager assignment after full application is approved

Common Acquisition Issues

- Landowner cannot be a client on appraisal (PRC 5096.510)
- Outdated Preliminary Title Reports
- Preliminary Title Reports not included and/or analyzed in the appraisal
- DGS Specifications
- Purchase and Sale Agreement
- Appraisal Date of Value must be within one year of WCB meeting



Common Acquisition Issues (cont'd)

- Conservation easement should be mostly complete prior to appraisal
- Talk to us early on about title issues
- Legal descriptions or changes to legal descriptions and encroachments
- Access
- State payments for all acquisitions should not exceed fair market value based upon a state approved appraisal




