Operational Updates

- CVP: Lewiston Dam releases at 1,450 cfs, long ramp down through end of June. Whiskeytown Dam releases at 300 cfs (spring pulse started on 5/15 with peak flows to 800 cfs and ramp down through the end of May to 175 cfs). Keswick Dam releases at 14,000 cfs (3rd pulse of 3 to 14,000 cfs ramp down beginning 5/24 through 5/26 expected 10,000 cfs to support Delta. Nimbus Dam releases at 3,500 cfs (refill storage management) Goodwin Dam releases at 1,450 cfs with a Stepped Release Plan spring pulse (pulse extends through end of May, 5/19 truncated pulse and holding higher flow to meet D-1641 requirement, 5/21 1,450 cfs and making further increases as needed. Jones Pumping Plant is exporting 3,500 cfs (controlling requirement D-1641 Vernalis 1:1 ended 5/19, began OMRI -5,000 cfs control proportional share on 5/20) adjusting to 3,200 cfs exports on 5/22. Federal share of San Luis Reservoir is 691 TAF. Delta Cross Channel remains closed throughout late May unless water quality issues, planning to open on Memorial Day weekend (5/24).
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,700 cfs (possible increase over the weekend). Clifton Court is exporting 600 cfs. State share of San Luis Reservoir is 736 TAF.
- Hydrology Update
 - Warm temperatures expected to cool over the next couple days and no rain in the forecast.
