- Operational Updates
 - CVP: Lewiston Dam releases at 1,150 cfs, ramp down into June. Whiskeytown Dam releases at 175 cfs (spring pulse complete). Keswick Dam releases at 10,000 cfs. Nimbus Dam releases at 3,500 cfs (reductions to 3,000 cfs on 5/29 and 2,500 cfs on 5/30). Goodwin Dam releases at 1,450 cfs (increases are a result of D-1641 requirements at Vernalis). Jones Pumping Plant is exporting 3,500 cfs (OMRI control and increases to 3,600 cfs on 5/29). Federal share of San Luis Reservoir is 655 TAF. Delta Cross Channel is currently closed and planned to open on Saturday 5/31 and to close on Monday 6/2.
 - SWP: Feather River (Oroville-Thermalito Complex) releases are at 2,300 cfs (holding). Clifton Court Forebay is exporting 600 cfs. State share of San Luis Reservoir is 696 TAF.
- Hydrology Update
 - It continues to be dry with the upcoming weekend to experience temperatures above 100 degrees. Temperatures are projected to go down into next week.
