#### • Operational Updates

- CVP: Lewiston Dam releases at 900 cfs, ramp down into June. Whiskeytown Dam releases at 150 cfs (pulse flow on 6/12 to peak at 500 cfs). Keswick Dam releases at 10,000 cfs (10,500 cfs on 6/13 for downstream demands). Nimbus Dam releases at 2,500 cfs. Goodwin Dam releases at 1,700 cfs (monthly Vernalis target expecting 1,500 cfs, decreases 6/12, 6/13, and 6/17 for recreation considerations). Jones Pumping Plant is exporting 2,700 cfs (3,200 cfs on 6/13, OMRI -5,000 cfs and D1641). Federal share of San Luis Reservoir is 579 TAF. Delta Cross Channel is currently closed and planned to open on Friday 6/13 and to close on Monday 6/16 for Delta water quality.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 4,000 cfs (4,500 cfs on 6/12). Clifton Court Forebay is exporting 2,000 cfs. DWR will be conducting an aquatic weed treatment on 6/30. Clifton Court Forebay Gates will be closed for 24 hours before and after the herbicide application. State share of San Luis Reservoir is 635 TAF.
- Hydrology Update
