Background

MRC topics must be referred by the Commission, which schedules them as appropriate, with the schedule detailed in the MRC work plan (Exhibit 1). The MRC prioritizes issues of imminent regulatory or management importance. Therefore, scheduling current topics and considering new ones require careful planning relative to existing workload and timing.

(A) MRC Work Plan and Timeline

Next Meeting

Topics anticipated for the November 2025 MRC meeting are marked in the November column of the work plan in Exhibit 1. Currently, three work plan topics are identified for discussion and two for updates for November. Staff may recommend changes to proposed agenda topics at the August 2025 Commission meeting, after assessing their readiness closer to that date. Staff welcomes guidance from MRC regarding scheduling of specific topics identified in the work plan.

Proposed Updates

Staff proposes renaming the planning document topic "*Red Abalone Recovery Plan (Statewide)*" to "*Red Abalone <u>Restoration</u> Plan (Statewide)*." The change is proposed since "recovery plan" is a term of art associated with species listed under the California Endangered Species Act and the federal Endangered Species Act; red abalone is not listed under either act. Therefore, "restoration" plan is the more appropriate term.

(B) Discuss and Recommend New MRC Topics

Today's meeting offers an opportunity to identify any potential new agenda topics to recommend to the Commission for referral to MRC. Staff has not identified any new topics for potential referral to MRC at this time.
