Notice of Preparation of a Draft Supplemental Environmental Impact Report

Subject: Notice of Preparation (NOP) of a Draft Supplemental Environmental Impact Report for Requested Incidental Take Permit for Crotch's Bumble Bee (State Clearinghouse No. 2002091018)

NOP Public Review Period: July 25, 2025, to August 25, 2025

The California Department of Fish and Wildlife (CDFW), as a responsible agency under the California Environmental Quality Act (CEQA), intends to prepare a Supplemental Environmental Impact Report (Supplemental EIR) for the potential issuance of an Incidental Take Permit (ITP) for Crotch's Bumble Bee (*Bombus crotchii*, and defined here as CBB) in connection with the development of the Canyon Hills Project (Project). The project applicant is Whitebird, Inc., doing business in California as California Whitebird, Inc. (Applicant),

In accordance with Section 15082 of the CEQA Guidelines, CDFW has prepared this Notice of Preparation (NOP) to provide the California Governor's Office of Land Use and Climate Innovation, any responsible and trustee agencies, and interested members of the public who submitted a request for such notices with information regarding the proposed ITP relating to the Project.

CDFW requests your written comments concerning the scope and content of the Supplemental EIR, including potential mitigation measures and alternatives to reduce the Project's potential environmental impact associated with issuance of the ITP. Comments must be submitted in writing according to directions below. If you represent a public agency, CDFW seeks written comments as to the scope and content of the environmental information in the Supplemental EIR that are germane to your agency's statutory responsibilities in connection with the proposed ITP relating to the Project.

In accordance with CEQA Guidelines Section 15082(b), there will be a 30-day period to comment on this NOP, beginning on July 25, 2025 and ending on August 25, 2025.

BACKGROUND: On October 19, 2005, the City Council of the City of Los Angeles (City Council) certified a Final Environmental Impact Report (Final EIR) for the Project and granted certain discretionary approvals for the Project. The approved Project includes 221 single-family residential lots, all of which are located on the north side of the I-210 Freeway. In May 2014, an Addendum to the Final EIR was prepared in connection with raising certain of the Project's street and pads.

PROJECT LOCATION: The development site for the Project (Project Site) includes approximately 300 acres of land and is located at 7000 La Tuna Canyon Road, Los Angeles, California, on the north side of the I-210 Freeway (I-210). The original project site included approximately 900 acres of land (Original Project Site) located on both sides of the I-210. The Project as originally proposed included 280 single-family homes. The reduced Project approved by the City Council included 221 single-family homes, all located on the Project Site on north side of the I-210, with all development eliminated on the portion of the Original Project Site located south of the I-210. The Applicant later recorded a conservation easement that permanently preserved all of the remaining approximately 600 acres within the Original Project Site (Public Open Space), including all of the entirety of the portion of the Original Project Site located south of the (I-210) and the western portion of the Original Project located north of the I-210. Fee title to the Public Open Space was then transferred to an affiliate of the Santa Monica Mountains Conservancy. See **Figure 1, Original Project Site and Regional Vicinity**, for the location of the Original Project Site within the context of the local area, and **Figure 2, Original Project Site, Current Project Site, and Public Open Space**, which shows the locations of the Original Project Site, the current Project Site and the Public Open Space.

PROJECT DESCRIPTION AND REQUESTED ACTION: The Applicant has filed an application with CDFW for an ITP under California Fish and Game Code Section 2081, subdivisions (b) and (c), a provision in the California Endangered Species Act, and Title 14 of the California Code of Regulations, Sections 783.0–783.8, to authorize the otherwise prohibited “take,” as defined by State law, of one candidate wildlife species, the CBB, incidental to the development of approximately 164 acres of potentially occupied habitat for the CBB within the Project Site as part of the Project.

POTENTIAL ENVIRONMENTAL EFFECTS: Pursuant to CEQA Guidelines Section 15063(a), CDFW has elected to proceed directly to the preparation of a Draft Supplemental EIR rather than preparing an Initial Study.

CEQA Guidelines Section 15041(b) outlines the authority of a responsible agency, as compared to a lead agency, to impose mitigation measures for a project:

(b) When a public agency acts as a Responsible Agency for a project, the agency shall have more limited authority than a Lead Agency. The Responsible Agency may require changes in a project to lessen or avoid only the effects, either direct or indirect, of that part of the project which the agency will be called on to carry out or approve.

CEQA Guidelines Section 15096(g)(1) includes a similar restriction:

(g) Adoption of Alternatives or Mitigation Measures.

(1) When considering alternatives and mitigation measures, a Responsible Agency is more limited than a Lead Agency. A Responsible Agency has responsibility for mitigating or avoiding only the direct or indirect environmental effects of those parts of the project which it decides to carry out, finance, or approve.

Therefore, the environmental review conducted by a responsible agency with respect to a discretionary approval must be limited to the environmental impacts within the scope of the discretionary approval before it. See, e.g., *Friends of Westwood, Inc. v. City of Los Angeles*, 191 Cal. App. 3d 259, 266-267, 272 (1987).

Accordingly, because CDFW is preparing the Draft Supplemental EIR associated with the potential issuance of an ITP for CBB, the Draft Supplemental EIR will focus solely on the Project's impact on the CBB.

SUBMITTING COMMENTS: CDFW will consider all written comments on the NOP regarding your views on how the potential issuance of the proposed ITP relating to the Project may affect the environment and the issues that should be addressed in the Draft Supplemental EIR. If you wish to submit written comments, please submit them no later than 5:00 p.m. on August 25, 2025 (the end of the 30-day comment period, which starts on July 25, 2025).

Your options for submitting comments are by U.S. mail or by email. Comments should include "Canyon Hills ITP – NOP Scoping Comments" in the subject line, and the name and physical address of the commenter should be contained in the body of the email or letter.

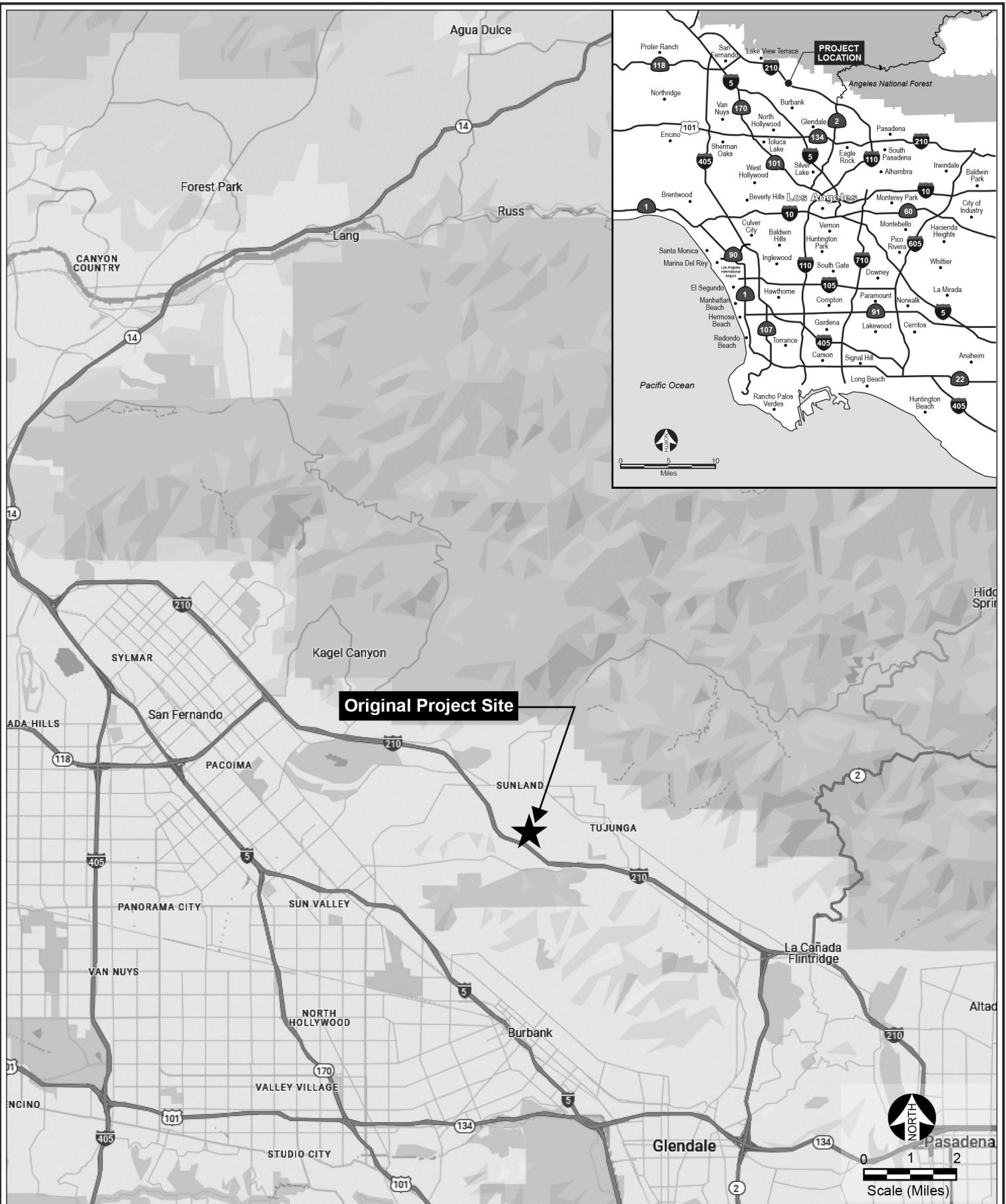


Figure 1

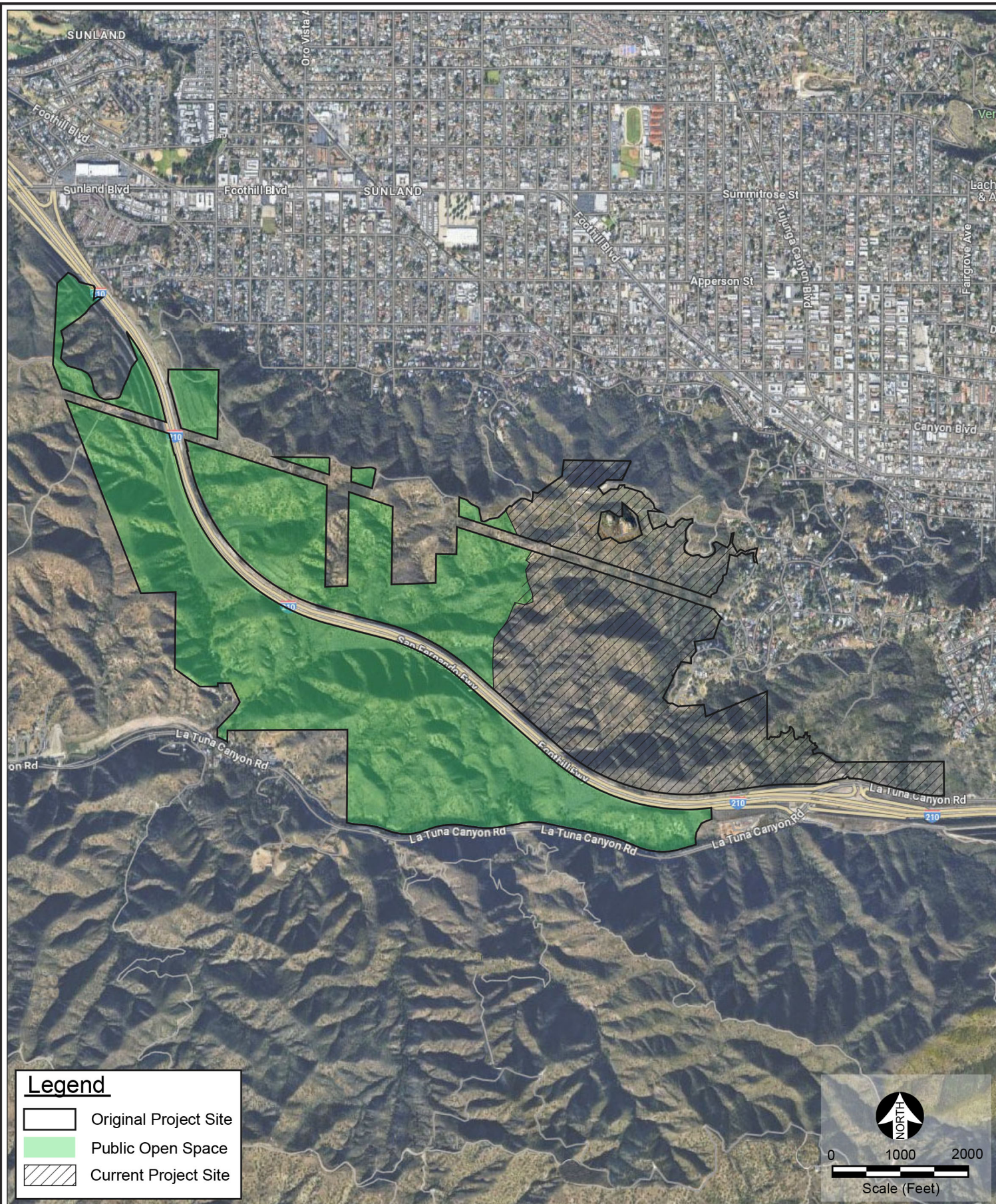


Figure 2
