(B) Methods of determining total length of fishes

Background

This item provides an opportunity for initial discussion with the Marine Resources Committee (MRC) regarding two potential regulatory changes, one initially proposed through the public regulation change petition process and the other by the Department. The proposals respond to Commission direction and public input and are intended to improve clarity and enforceability in recreational fisheries regulations.

(A) Recreational Use of Hand-Held Harpoons and Flying Gaffs to Assist Anglers in Landing Tuna

Current regulations in Section 28.20 allow the use of a harpoon to assist in the take of Pacific halibut with limitations defined in Section 28.95. Section 28.95 specifies that harpoons may be used to take skates, rays, and sharks (except white sharks) and to assist in the take of Pacific halibut. However, no other finfish species are allowed to be taken or landed with harpoons.

In April 2024, the Commission received Petition 2024-04, requesting a regulatory amendment to allow the use of harpoons — alongside a gaff or net — as legal aid to assist in landing large migratory finfish in recreational fisheries (Exhibit 1). The Commission referred the petition in August 2024 to the Department for review; in December 2024, the Department recommended granting the petition in part. Specifically, the Department supported explicitly authorizing the use of harpoons to assist in landing otherwise legally caught tuna species in the recreational fishery (Exhibit 2). Commission referred the topic to MRC and requested that the Department develop regulatory options that would align with the petition's intent while ensuring enforceability.

Update

In response to the Commission's request, the Department has developed regulatory options to authorize the use of hand-held harpoons as well as flying gaffs to assist in landing tuna taken by angling. Today, the Department will present the proposed regulatory options, along with additional clarifying amendments, for initial discussion by MRC and the public (Exhibit 3). Based on the outcome of today's discussion, a final review and potential MRC recommendation is anticipated in March 2026.

(B) Clarifying the Methods for Determining Total Length of Fish and Invertebrates with Recreational Size Limits

Current regulations in Section 1.62 state that "no fish, mollusks or crustaceans less than the legal minimum size or greater than the maximum legal size (total, fork or alternate) may be possessed, except as otherwise provided". While this section defines total, fork, and alternate length measurements, it does not reference additional methods, such as "fanning" or "swinging" the tail, which are currently expressly allowed for salmon and halibut in other regulatory and code sections. (See Exhibit 3 for visual display of these methods.) The lack of clarity has led to ongoing public confusion about how to legally measure finfish.

In response, the Department has developed a regulatory proposal to clarify and standardize the methods used to determine fish size. The proposed changes would extend the currently-allowed practices of "fanning" and "swinging" the tail—previously specified for salmon and halibut—to all finfish species. Additionally, the proposal would update terminology by replacing "fish, mollusks, or crustaceans" with "fish and invertebrates," and would clarify that measurement methods for invertebrates are specified within their respective regulatory sections.

The Department will present an overview of its proposal at today's meeting for initial discussion by MRC and the public (Exhibit 3).

Initial Vetting

This meeting serves an initial opportunity for interested parties to provide input to MRC and the Department on the potential regulations described above. A second opportunity for discussion will occur at the March 2026 MRC meeting, where the committee may develop recommendations for the Commission regarding the scope and timing of each potential rulemaking.

The Department's presentation today will provide an overview of both topics under consideration (Exhibit 3).

Clarification of the regulations to authorize the use of a harpoon as a landing aid.

Harpoons are a common landing aid for large tuna on small boats. In recent years, more and larger bluefin tuna have been caught along the California coast, bringing to the fore the lack of clarity in the regulations regarding the use of a harpoon as a landing aid.

Online discussions, questions to wardens, etc all struggle to make sense of whether it is legal to harpoon a hook-and-line caught fish at the boat as a way to control and land the fish.

Most of the discussions revolve around references to harpoons as a method of take, and extrapolate to form an opinion about whether a fish landed with a harpoon was "taken" with a harpoon. Some point out that a netted salmon or a gaffed lingcod were not "taken" with a net or a gaff. Others have a different read.

The lack of certainty creates a risk of unintentional illegal activity for fishermen, and a difficult enforcement issue for wardens. It seems it should be fairly straightforward to amend the regulations to speak specifically to the use of harpoons as a landing aid. Likewise, it doesn't seem like permitting harpoons as a landing aid should be overly controversial vs. a gaff.



At their August 14, 2024, meeting, the California Fish and Game Commission (Commission) referred a petition for regulation change (2024-04) to the Department of Fish and Wildlife (Department) for review and recommendation. The petition submitted by Benjamin D. Mitchell (Applicant), requests to amend Section 27.90, 28.65 and 195 of Title 14, CCR. The proposed change would explicitly allow the use of a harpoon as a landing aid for tuna species in the recreational fishery.

Section 28.20, Title 14, CCR, allows for the use of a harpoon to assist with the take of Pacific halibut with limitations set forth by section 28.95, Title 14, CCR. Section 28.95, specifies that harpoons may be used to take skates, rays, and sharks and to assist in the taking of Pacific halibut. No other species are explicitly allowed to be taken or landed with harpoons.

Outside of California, harpoons are a common landing aid for large tuna on small recreational boats. In recent years, more and larger (250+ lbs) bluefin tuna have been caught along the California coast, highlighting the need for a new regulation allowing the use of a harpoon as a landing aid for tunas.

The Department recommends this petition be granted in part and that a future rulemaking be considered to increase clarity and explicitly allow for the use of harpoons to assist with the landing of otherwise-legally-caught tuna species in the recreational fishery.
