- Operational Updates
 - CVP: – Starting up north, Keswick is releasing 15,000 cfs, Nimbus is releasing 11,000 cfs and going down to 9,500 on 1/9. Goodwin is at 200 cfs, Jones Pumping Plant is at 4,200 cfs.
 - SWP: FR releases are decreasing from 10,000 cfs to 6,000 cfs, with further decreases likely. Clifton Court intake is at 3,400 cfs and will likely be decreasing over the next couple of days to continue meeting the OMRI target of -5000. State share of San Luis Reservoir is at 969 TAF.
 - Hydrology Update: Higher runoff from recent storm events, but no precipitation is forecast for this week or next week. We will be in a dry streak for a while.

• **Item 1 – Storm Flex**

Reclamation is looking at assessments and evaluations right now. They will know more by the end of the day.

DWR is looking into operating under Storm Flex if conditions allow. They will work to have a coordinated approach with Reclamation if and when this happens.

USFWS wanted to know how long Storm Flex might last, if triggered.

DWR is not sure how long it will take; it depends on QWEST and flows, and any of those could be cause for an offramp. It would be at least for a week unless there is a COA trigger that would offramp.

DWR – Last year, one of the COAs was triggered so we offramped.

CDFW – If we check all those 8 boxes then it is on WOMT to request that DWR use real-time estimates of species to assess potential entrainment differences.

CDFW – To refresh WOMT's memory, on 2/3/2025 WOMT approved Storm Flex to begin on February 4. Exports were ramped up directly after WOMT for 6 days and then the OMR target went back to -5000 on February 10 because turbidity was exceeded at OSJ.

CDFW explained that not all 8 boxes for Storm Flex have been checked yet. If and when that happens, CDFW recommends a quickly held ad hoc meeting for WOMT.

WOMT agreed to call a meeting if Storm Flex conditions are met.

- **Item 2 - Third Spring Surrogate Release by CNFH**

Surrogate release group requiring approval by WOMT:

3rd Surrogate Release: Release of ~75k by January 16, but ideally as soon as possible due to the precipitation event and since it has been at least a week after the previous surrogate release.

Item 3 - Proportional Share COA 8.7

CDFW – If we end up being in proportional share condition, the Federal government is prohibited from using State facilities in violation of the law. If this prohibition does not meet the operations conditions of the relevant COA, then DWR provides CDFW the written estimate of the exports for both SWP and CVP facilities that would be required.
