- Operational Updates
 - CVP: Shasta is continuing to release at 15,000 cfs, Lake Natoma is currently at 5500 cfs and decreasing. It should be at 3900 cfs by 1/18. San Luis Federal share is at 525 TAF.
 - SWP: Feather River releases are at 5100 cfs. This will continue for the next couple of days. This should likely decrease around 1/17. The Clifton Court intake is at 2000 cfs. And the State share of San Luis is at 976 TAF.
 - Hydrology Update: We are still seeing the tail end of the most recent rain events, adding additional runoff into the system. This is beginning to taper off. We are no longer overtopping Fremont Weir into Yolo Bypass. It is assumed that the adult fish passage structure at Fremont Weir is open. No upcoming precipitation in the forecast for the system.

CDFW received an email from DWR with reporting on DWR's proportional share for First Flush operation over the holidays. They have not received that same accounting for the current implementation for 8.4.5. When a COA forces a change of operations, DWR is required to submit to CDFW a report on how DWR will meet their proportional share, in this case OMRI of -3500. Their expectation is that this forecasting would be sent when

the operational change begins. They also want to follow along with those operations as close to real time as possible. DWR will forecast these numbers with the caveat that they could change.

- Item 2 – Timing for Implementation of 8.4.5

CDFW pointed out that the salvage event that triggered that action happened on 1/9, and DWR had 3 days to modify exports for OMRI. The new OMRI of -3500 should have started on Monday instead of Tuesday. In the past it always happened within 3 days of the actual event. DWR admitted to some confusion on the date of the trigger and offered to either a) continue on with the action beginning on 1/13; or b) change exports so that the OMRI from 1/12 to 1/18 will average -3500. CDFW will confer offline and deliver their answer to this offer later. There is a document that lays out the whole process of notification that CDFW intends to update in coordination with DWR.

- Item 3 – Question about Combined Assessment

CDFW wanted to know why it's called the "Combined Assessment" and wondered if it might be a multi-agency document. It's "combined" since it's concerned with both salmonids and smelt. Reclamation authored this Assessment on their own.

- Item 4 – Storm Flex Assessment

USFWS asked why WOMT had received an older Storm Flex Assessment (1/6 – 1/13) for this meeting. The reason was that it was sent late in the week last week, after our regularly scheduled WOMT meeting (but before our ad-hoc meeting). It was also mentioned that Reclamation did not actually execute a Storm Flex change in operations. However, Reclamation was already at maximum capacity so would have had to rely on SWP to increase exports. On Tuesday, CVP was at its max of 4200 cfs.
