Summary of Previous/Future Actions

- Discussed regional marine protected area (MPA) petition evaluation meetings for 2026 October 8-9, 2025
- Approved proposed 2026 dates and locations for three regional MPA petition evaluation meetings December 10-11, 2025
- Today, discuss and consider approving proposed changes to May 5 and 6 meetings and draft agenda items for upcoming meetings February 11-12, 2026**

Background

The next regularly scheduled Commission meeting is April 15-16, 2026 in Sacramento, followed by three meetings focused on MPAs scheduled for April 21, May 5, and May 19.

At its October 2025 meeting, the Commission agreed that future reviews of MPA petitions and evaluations will be conducted by the Commission, beginning with three, in-person, regionally based meetings using a committee-style format with all commissioners. At its December 2025 meeting, the Commission approved adding three Commission meeting dates for April 21, May 5, and May 19, with locations in the Half Moon Bay area, Santa Barbara area, and Oceanside or northern San Diego area, respectively.

After multiple conversations with agency partners and stakeholders, staff has concluded that the MPA discussions in the Santa Barbara area will likely require more than one day. Given the number of petitioned actions represented in that area, another half day is advisable. The additional time could most easily be achieved by combining the May 5 regional meeting with the May 6 teleconference meeting and then extending the expected end time on May 6. The two rulemaking topics currently scheduled for May 6 related to Klamath River Basin sport fishing and Central Valley sport fishing can be added to the regional meeting agenda.

Phone and webinar options will be available for all meetings to allow public participation remotely. Potential agenda items for the multiple meetings are provided in exhibits 1-3 for consideration and potential Commission approval. No unusual logistics are expected.

For regularly scheduled two-day Commission meetings in 2026, marine items will generally be heard on the first day, and wildlife and inland fisheries items on the second. Except for regional MPA petition evaluation meetings, all Commission and committee meetings are scheduled in the Sacramento area through December 2026 due to ongoing budget constraints.

Potential Agenda Items for the April and May 2026 Commission Meetings

The next Commission meetings are scheduled for April 15-16, 2026 in Sacramento, and for April 21, May 5, and May 19, 2026 in the Half Moon Bay area, Santa Barbara area, and San Clemente area, respectively. All meetings will be conducted in person and via Zoom, with phone options for the public.

The Commission also has a May 6 teleconference meeting scheduled for annual inland fisheries rulemakings related to salmon. However, during the February 11-12 Commission meeting, staff will recommend combining the May 6 teleconference agenda items with the May 5 in-person meeting, creating a single, day-and-a-half meeting. This adjustment will allow some marine protected area (MPA) petition discussion to take place on May 6.
