INSTRUCTIONS FOR COMPLETING THE LICENSED GAME BIRD SEAL ORDER FORM

Please read instructions. Incomplete order forms will be returned and could delay the processing of your order.

- Licensed Game Bird Club Seals (LGBCS) are only available from the California Department of Fish and Wildlife's (CDFW), License and Revenue Branch in Sacramento. Contact CDFW's, License and Revenue Branch at (916) 928-5846 or <u>SPU@wildlife.ca.gov</u> if you need additional information regarding LGBCS.
- Additional LGBCS order forms are available at <u>wildlife.ca.gov/Licensing/Game-Bird-Club</u>.
- LGBCS orders will not be processed until your Licensed Game Bird Club License is valid.
- Mail the LGBCS order form, and a cashier's check, money order, personal check, or completed credit card authorization form with the appropriate fee to the California Department of Fish and Wildlife Attention: License and Revenue Branch, PO Box 944209, Sacramento, CA 94244-2090.
- Allow 20 business days for processing of your order.

PAYMENT POLICY

Personal Checks will be accepted by CDFW if name and address are imprinted on the check. Checks returned to the CDFW due to insufficient funds will render your license invalid. The CDFW may also deny the issuance or renewal of a license if a person has failed to reimburse CDFW for the amount due. Any activity performed without a valid license is a violation of the Fish and Game Code and therefore subject to enforcement action.

Credit Cards - Licenses, permits, and other entitlements may be purchased with debit or credit cards displaying the Visa or Mastercard logo.

Cash is not accepted at CDFW license sales offices.
