Important - Monthly Reports

California Code of Regulations (CCR), Title 14,
Section 600.4(h), requires licensees to submit
monthly Licensed Domesticated Migratory Game
Bird Reports to the Department of Fish and
Wildlife, License and Revenue Branch, within 10
days after the close of each month during shooting
season. Renewals will not be processed if you
have not submitted your monthly reports.

- Large orders are sent by a delivery service
that does not provide delivery to P.O. Boxes,
so please provide the appropriate delivery
address.
- Next day air service and Saturday delivery of
orders is not available.



Check List for Renewing Your Licensed Domesticated Migratory Game Bird Shooting Area

Please read the instructions included with the renewal before completing. Incomplete reports and/or renewals will be returned and may delay the issuance of your license. Mail the renewal to the address listed on the renewal.

- ✓ Review the preprinted information on your worksheet and make any necessary changes or corrections.

- ✓ If you are not the owner of all the parcels, you must submit written verification from the landowner(s) that you have exclusive hunting rights on the land in question if you are not the owner of all land listed on the renewal. The verification shall state that the applicant has exclusive hunting rights on the land in question for the total period of the term of the license, which is July 1 to June 30, or for the remainder of the period if issued after July 1, pursuant to CCR, Title 14 Section 600.4(a)(1).

- ✓ Sign and date your renewal worksheet.

- ✓ If you failed to submit the monthly reports, submit the reports with your renewal.

- ✓ Enclose check or money order. If paying by credit card, sign the enclosed form and include the expiration date of the credit card, CVC number on the back of the card and your daytime telephone number.

- ✓ Allow 15 business days for your worksheet to be processed.
