INSTRUCTION FOR COMPLETING THE FUR DEALER AND FUR AGENT LICENSE APPLICATION

Please allow 15 business days for processing. Incomplete applications will be returned and could delay the issuance of your license. Contact the License and Revenue Branch at (916) 928-5852 or SPU@wildlife.ca.gov, if you need additional information regarding fur dealer and/or fur agent licenses.

1. It is mandatory to complete all items unless specified as voluntary.
2. Sign and date the application.
3. Mail this application, a copy of your identification and a cashier's check, money order, personal check* or credit card** authorization form with the appropriate fee to the Department of Fish and Wildlife, License and Revenue Branch, 1740 N. Market Blvd., Sacramento, CA 95834 or apply in person. **DO NOT SEND CASH.*****

Fur Dealer - Every person engaging in, carrying on, or conducting wholly or in part the business of buying, selling, trading, or dealing in raw furs of fur bearing mammals or nongame mammals is a fur dealer and must procure a fur dealer license.

Fur Agent - Any person employed by a licensed fur dealer to engage in the business of buying, selling, trading, or dealing in raw furs on the behalf of the fur dealer and not on his own behalf is a fur agent and must procure a fur agent license.

Renewal Applicants - Pursuant to Section 696, Title 14, of the California Code of Regulations (CCR), fur dealers are required to submit the Fur Dealer Report Form (DFW 1425b) no later than July 1, each year.

IDENTIFICATION REQUIREMENTS

Section 700.4(c), Title 14, of the CCR states any applicant applying for any license, tag, permit, reservation or other entitlement issued via the Automated License Data System (ALDS) shall provide valid identification. Acceptable forms of identification include:

- Any license document or Get Outdoors identification number (GO ID) previously issued via ALDS
- A valid driver's license or identification card issued to him or her by the Department of Motor Vehicles or by the entity issuing driver's licenses from the licensee's state of domicile
- US Military Identification Cards (Active or reserve duty, dependent, retired member, discharged from service, medical/religious personnel)
- US Certificate or Report of Birth Abroad
- US Birth Certificate
- Tribal Identification Card, as defined by each sovereign tribal nation
- US Passport
- A foreign government-issued photo identification
- Certificate of Naturalization or Citizenship
- Birth Certificate or passport issued from a US Territory

BUSINESS DOCUMENTATION

All business applicants must provide documentation identifying the business' structure type. Acceptable forms of business identification include:

- Articles of Incorporation
- Statement of Partnership
- Registration as a Limited Liability Partnership; or
- Certificate of Limited Partnership
- Statement of Partnership Authority

If a business' identification names individual(s), each individual must provide a valid individual identification as described above and provide their date of birth, sex, hair and eye color, height and weight.

NOTICE

Disclosure Statement - Under Fish and Game Code (FGC) Sections 4030-4043, and Section 696, Title 14, of the CCR, the Department is authorized to collect information from applicants to maintain a record of licensure. All information requested on this application is mandatory unless otherwise indicated. Under FGC Section 391, personal information submitted on this application may be released for law enforcement purposes, pursuant to court order, or for official natural resources management purposes.

A licensee may obtain a copy of his/her license records maintained by the Department by submitting a written request to the Custodian of Records, Department of Fish and Wildlife, 1740 N. Market Blvd., Sacramento, CA 95834 or LRB@wildlife.ca.gov. All requests must include the requester's name, address, and telephone number.

PAYMENT POLICY

***Personal Checks** will be accepted by the Department if name and address are imprinted on the check. Personal checks returned to the Department due to insufficient funds will render your license invalid. The Department may also deny the issuance or renewal of a license if a person has failed to reimburse the Department for the amount due. Any activity performed without a valid license is a violation of the Fish and Game Code and therefore subject to enforcement action.

****Credit Cards** - Licenses, permits, tags, stamps, or registrations may be purchased with a Visa or MasterCard.

*****Cash** - The Department does not accept cash at its License and Revenue Branch and regional license sales offices.
