Subject: 2003 Annual Deer Creek Adult Spring-run Chinook Salmon Survey

On the 5 and 11 of August 2003, Deer Creek, Tehama County, was snorkel surveyed to count adult spring-run Chinook salmon. The survey reaches extended from Upper Deer Creek Falls downstream to Dillon Cove, a distance of 25 miles (Figure 1). **A total of 2,759 spring-run Chinook salmon was observed.**

The salmon counts are summarized below:

This year's survey was terminated at Dillon Cove due to the low numbers of salmon observed in the last 3 mile reach. This year 97% of the salmon were holding upstream of Ponderosa Way at elevations greater than 1700 ft. In addition to the live salmon counted, 16 salmon carcasses were observed. These carcasses are not included in the total count. Since the same reaches are surveyed at the same time each year, this count provides an index of run size. Snorkel counts are not expanded to a population estimate. In order to minimize harassment and stress to holding salmon, only one survey is conducted during the summer holding period.

Water flow in Deer Creek during the survey was 126 cfs, (recorded at the USGS gage, DCV). From 1995 thru 2001 August flows at the gage have ranged between 74 and 202 cfs. The Department has water temperature loggers placed in salmon holding and spawning habitat between Upper Falls and Trail 2E17. These temperature loggers will be downloaded this fall.

This years count is the highest since snorkel surveys of the holding habitat were first made in 1992. During the previous 11-years of record, counts have ranged from a high of 2,185 fish in 2002 to a low of 209 fish in 1992 (Table 1). The average count over this time period is 1022 salmon. Between 1940 and 1964, an average of 2,200 spring-run salmon was counted annually using fish ladder counts and carcass surveys. This year's count of 2,759 salmon represents an increase from both the 1999 and 2000 cohorts of 1,591 and 637, respectively. Although, since the age structure (percentage of 2-, 3-, and 4-year-olds) of Deer Creek spring run is not known at this time, caution should be used when speculating the replacement rate of this years run. Due to the difficulty in separating grilse-sized fish in pools with numerous salmon, grilse are included in the adult counts.

Lassen National Forest fisheries crews will survey Deer Creek again in October from the Upper Falls to Dillon Cove for spawning success, redd distribution, and carcass recovery for DNA tissue collection.

This year's survey included participants from the Department of Fish and Game (CDFG), U.S. Forest Service Lassen National Forest (LNF), National Oceanic and Atmospheric Administration Fisheries (NOAA), and U.S. Fish and Wildlife Service's Northern Central Valley Fishery Resource Office (USFWS). The first prize winner of this year's "Deer Creek Salmon Guess Contest," held during the pre-snorkel camp out, was Jimmy Faukner with a guess of 2750 salmon. Jimmy won the prized DFG "Sworn to Protect" T-shirt. Thank you to all who volunteered their time to participate in the year's annual Deer Creek salmon count.
