I understand and agree to abide by the following terms and conditions of this permit:

1. Only live white sturgeon (**Acipenser transmontanus**) not to exceed 8 inches in total length and abalone (**haliotis sp.**) possessing a mark or tag approved by the Department shall be possessed or sold.
2. Such sturgeon and abalone shall originate only from a registered aquaculture facility authorized by the Department to rear white sturgeon and abalone and shall be sold only from the premises of the outlet named above.
3. Such sturgeon and abalone are to be sold to private individuals for use as pets, or to retail outlets to be resold as pets, and shall not be sold to commercial dealers for human consumption.
4. A log of all sales or deliveries of sturgeon and abalone shall be kept on forms provided by the Department, and shall be shown to any authorized law enforcement agent upon request.
5. I understand that this permit shall be kept at the premises named above and shown to a Department officer upon request.
