INSTRUCTIONS FOR THE LICENSED GUIDE EMPLOYEE REGISTRATION APPLICATION

Please allow 15 business days for processing the application. Incomplete applications will be returned and will delay the issuance of your registration. Contact the License and Revenue Branch at (916) 928-5846 or SPU@wildlife.ca.gov if you need additional information regarding the guide employee registration application.

1. It is mandatory to complete all items unless specified as voluntary.
2. Completed application must be accompanied by:
 - a. Employee Registration Fee
 - b. A copy of documentation showing that each employee is covered by workers' compensation insurance.
 - c. A copy of documentation showing that each employee is subject and reported to the state and federal taxing authorities for withholding of income tax.
3. The application must be signed by both employee applicant and employer.
4. Mail this application, a copy of your identification, copies of documents described above and a cashier's check, money order, personal or business check* or credit card** authorization form with the registration fee to the Department of Fish and Wildlife, License and Revenue Branch, P.O. Box 944209, Sacramento, CA 94244-2090. **DO NOT SEND CASH*****

NOTE: A permit must be obtained from the U.S. Department of the Interior or Department of Agriculture when guiding or packing on lands under the jurisdiction of that federal agency. Operators carrying passengers in powered vessels, in navigable waterways must have a valid U.S. Coast Guard license, and U.S. Coast Guard Certificate of Inspection for boats carrying more than six passengers, and must carry safety equipment (e.g., fire extinguisher, personal floatation devices, etc.) aboard the vessels. Operators of for-hire vessels carrying more than three passengers for-hire on non-navigable state waters must possess a valid For-Hire Vessel Operator's License, and For-Hire Vessel Carriers must also obtain a For-Hire Vessel Carrier Insurance Certificate issued by the Division of Boating and Waterways (DBW). IDENTIFICATION REQUIREMENTS

Section 700.4(c), Title 14, of the CCR states any applicant applying for any license, tag, permit, reservation or other entitlement issued via the Automated License Data System (ALDS) shall provide valid identification. Acceptable forms of individual identification include:

- Any license document or Get Outdoors identification number (GO ID) previously issued via ALDS
- A valid driver's license or identification card issued to him or her by the Department of Motor Vehicles or by the entity issuing driver's licenses from the licensee's state of domicile
- US Military Identification Cards (Active or reserve duty, dependent, retired member, discharged from service, medical/religious personnel)
- US Birth Certificate
- Tribal Identification Card, as defined by each sovereign tribal nation
- US Passport
- A foreign government-issued photo identification
- Certificate of Naturalization or Citizenship
- Birth Certificate or passport issued from a US Territory
- US Certificate or Report of Birth Abroad

Applications submitted by individuals for businesses must provide documentation identifying the business' structure type. Acceptable forms of business identification include:

- Articles of Incorporation
- Articles of Organization
- Certificate of Limited Partnership
- Statement of Partnership Authority

NOTICE

Disclosure Statement — Under Fish and Game Code Sections 2535–2546 and Section 745, Title 14, of the CCR, the Department of Fish and Wildlife is authorized to collect information from applicants to maintain a record of licensure. All information requested on this application is mandatory unless otherwise indicated. An applicant's name and city of residence may be provided to the public if requested. Other personal information submitted on this application may be released for law enforcement purposes, pursuant to court order, or for official natural resources management purposes. A licensee may obtain a copy of his/her license records maintained by the Department by submitting a written request to the Custodian of Records, Department of Fish and Wildlife, License and Revenue Branch, P.O. Box 944209, Sacramento, CA 94244-2090. All requests must include the requestor's name, address, and telephone number.

PAYMENT POLICY

***Personal or business checks** will be accepted by the Department if name and address are imprinted on the check. Checks returned to the Department due to insufficient funds will render your registration invalid. The Department may also deny the issuance or renewal of any registration if a person has failed to reimburse the Department for the amount due. Any activity performed without a valid registration is a violation of the Fish and Game Code and therefore subject to enforcement action.
****Credit Cards** – Licenses, permits, tags, stamps, or registrations may be purchased with a Visa or MasterCard.
*****Cash** is not accepted at California Department of Fish and Wildlife sales offices.
