*April 13, 2009 Draft*

The tables in this document provide supporting information for the Round 1 marine birds evaluation results. Results are given for individual marine protected areas (MPAs) within draft MPA arrays and draft external MPA proposals.

Only state marine reserves were considered in the Round 1 analyses. Additionally, the Round 1 analyses brought a few data gaps to our attention; these numbers have been flagged in Table 1 with asterisks and will be updated with the most current numbers prior to the Round 2 analyses.
