Information Regarding Amendments of Lake or Streambed Alteration Agreements

The entity responsible for complying with the terms of an agreement (Permittee) may request the California Department of Fish and Wildlife (CDFW) to amend a Lake or Streambed Alteration Agreement (Agreement), provided the request and applicable fee are received by CDFW in writing prior to the agreement's expiration. If the request and applicable fee are not received prior to the agreement's expiration, CDFW will be unable to accept the request. In that case, the Permittee will need to notify CDFW in accordance with Fish and Game Code section 1602 or section 1611 and obtain a new agreement.

In order to request an amendment, the Permittee shall complete and submit the attached Amendment Request form, with the correct fee, to the <u>CDFW regional office</u> that serves the area where the project is located.

A project may not be added to an agreement by amendment unless the agreement specifies otherwise.

5. AMENDMENT DESCRIPTION

- Written description of all project activities with detailed step-by-step description of project implementation.
- Include detailed information about new channel or bank clearing and/or structures (e.g., rip-rap, culverts) that will be placed or modified in or near the bed, channel or bank of a stream, river, or lake, and any modifications of bed, channel, or bank.
- Specify the volume and dimensions of any new proposed structures (e.g., bridge) and all associated materials (e.g., rip-rap).

Diagrams, plans, reports, maps, and photos:

- Include any new diagrams, design plans, construction specifications, biological survey reports, hydrological reports, well completion reports, and labeled photos of the proposed project location(s).
- Enclose map(s) (e.g., topographic and satellite imagery) that identify all of the project location(s) for any projects that you are amending, proposing, or have completed and mark each project accordingly.
- Map(s) should include an overview of the entire parcel/project area (i.e., bird's-eye-view) showing the location of each project feature (i.e., activity site), significant landscape features (e.g., streams, roads structures), project specific features (e.g., stockpile areas, areas of any temporary or permanent impacts), and project access/egress locations.
- Map(s) shall denote a north arrow, scale, parcel number(s), parcel boundaries, and should represent present site conditions.
 - If your project is cannabis related, provide an updated map that identifies all cannabis cultivation facilities, streams, roads, stream crossings, structures, ponds, and water storage facilities.

- Enclose labeled photos of each project site for project that are being proposed or have not yet been completed. For stream related projects, include a minimum of one upstream and one downstream view of the project site. Photos should represent current site conditions.
- Enclose any deliverables or reporting requirements identified in the agreement that have not been submitted to date.
- Provide any other relevant information to assist CDFW in determining potential impacts to a river, stream, or lake.
