Information Regarding Extensions of Lake or Streambed Alteration Agreements

The entity responsible for complying with the terms of an agreement (Permittee) may request the California Department of Fish and Wildlife (CDFW) to extend the term of a Lake or Streambed Alteration Agreement (Agreement), provided the request and applicable fee are received by CDFW in writing prior to the agreement's expiration. If the Permittee submits an extension request prior to the agreement's expiration, the agreement may remain in effect until CDFW acts on the request or for one year after the agreement expires, whichever occurs first. If the request and applicable fee are not received prior to the agreement's expiration, CDFW will be unable to accept the request. In that case, the Permittee will need to notify CDFW in accordance with Fish and Game Code section 1602 or section 1611 and obtain a new agreement in order to begin or continue the work covered by the expired agreement.

The term of an agreement may only be extended one time.

In order to request an extension, the Permittee shall complete and submit the attached Extension Request form, with the correct fee, to the [CDFW regional office](#) that serves the area where the project is located.

Note: If the agreement was issued by CDFW prior to January 1, 2004, extensions are governed by former Fish and Game Code section 1601(g) or 1603(g), pursuant to which CDFW may extend an agreement more than one time.
