



**CERTIFICATE OF NONRECEIPT (CNR)**

**INSTRUCTIONS:** This form must be completed to request the replacement of an undelivered license, permit, or entitlement that was sent by mail from a California Department of Fish and Wildlife (CDFW) Office or by our online or telephone sales services. The CDFW will replace the undelivered document(s) at no charge if the following criteria is met:

1. The original purchase and payment are verified and there are no pending issues (e.g., returned in mail, revocations, and payment errors).
2. At least 15 days but no more than 90 days have passed from the mail fulfillment date. If after 90 days, a duplicate must be purchased.

**Submit the completed form to the CDFW Office where the original items were purchased, or to the License and Revenue Branch for online and telephone sales purchases.** (CDFW office locations listed on page 2.)
