CALIFORNIA HALIBUT BOTTOM TRAWL PERMIT TRANSFER REQUIREMENTS

TRANSFER TO A REPLACEMENT VESSEL

Submit the following:

- 1. Notarized California Halibut Bottom Trawl Vessel Permit Transfer Application.
- 2. Original current California Halibut Bottom Trawl Permit.
- 3. Copy of current Commercial Boat Registration for the replacement vessel.
- 4. Copy of current proof of vessel ownership for the permitted vessel and the replacement vessel.
- 5. Copy of United States Coast Guard Certificate of Documentation or survey conducted by licensed marine surveyor that shows the length, breadth, and depth of both the permitted vessel and the replacement vessel.

TRANSFER TO PROPOSED TRANSFEREE

Submit the following:

- 1. Notarized California Halibut Bottom Trawl Vessel Permit Transfer Application.
- 2. Original current California Halibut Bottom Trawl Permit.
- 3. Original current Commercial Boat Registration for the permitted vessel.
- 4. Copy of proposed permit holder's current Commercial Fishing License.
- 5. Copy of proposed permit holder's proof of vessel ownership for the permitted vessel.

DEATH OF PERMIT HOLDER

Submit the following:

- 1. Notarized California Halibut Bottom Trawl Vessel Permit Transfer Application.
- 2. A copy of the permit holder's death certificate.
- 3. Proof that the applicant is the executor/authorized representative of the deceased's estate.
- 4. Original notarized California Halibut Bottom Trawl Vessel Permit Transfer Application <u>submitted within one year</u> of the permit holder's death.
- 5. Documentation listed under "Transfer to Proposed Transferee" and/or "Transfer to a Replacement Vessel" (see above).

IDENTIFICATION REQUIREMENTS

CCR, Title 14, Section 700.4(c) states any applicant applying for any license, tag, permit, reservation or other entitlement issued via the Automated License Data System (ALDS) shall provide valid identification. Acceptable forms of identification include:

- Any license document or Get Outdoors identification number (GO ID) previously issued via ALDS.
- A valid driver's license or identification card issued to by the Department of Motor Vehicles or by the entity issuing driver's licenses from the licensee's state of domicile.
- US Military Identification Cards (Active or reserve duty, dependent, retired member, discharged from service, medical/religious personnel).
- Birth Certificate or passport issued from a US Territory.
- US Passport
- US Birth Certificate
- US Certificate or Report of Birth Abroad
- Certificate of Naturalization or Citizenship
- Tribal Identification Card, as defined by each sovereign tribal nation.
- A foreign government-issued photo identification

BUSINESS DOCUMENTATION

If the permitted vessel or the replacement vessel is owned by a business, you must provide documentation showing the business entity type. Acceptable forms of documentation include:

- Articles of Incorporation
- Certificate of Limited Partnership
- Articles of Organization
- Statement of Partnership Authority

PROOF OF VESSEL OWNERSHIP

Pursuant to FGC Section 7601, the following may be submitted as proof of vessel ownership:

- United States Coast Guard Certificate of Documentation; or
- California Department of Motor Vehicles Vessel Registration; or
- Out of state vessel registration

RELEVANT FISH AND GAME CODE SECTIONS

CALIFORNIA HALIBUT BOTTOM TRAWL VESSEL PERMIT TRANSFER

8494(b) A California halibut bottom trawl vessel permit shall be issued annually, commencing with the 2006 permit year and an applicant shall have been issued a California halibut bottom trawl vessel permit in the immediately preceding permit year.

(c) Permits issued pursuant to this section may be transferred only if at least one of the following occur:

(1) The commission adopts a restricted access program for the fishery that is consistent with the commission's policies regarding restricted access to commercial fisheries.

(2)(A) Prior to the implementation of a halibut trawl restricted access program, the department may consider requests from a vessel permitholder or his or her conservator or estate representative, as applicable, to transfer a vessel permit to a vessel consistent with the requirements of subparagraph (B) or (C). The department may request information that it determines is reasonably necessary from the permitholder or his or her conservator or heirs or estate for the purpose of verifying statements in the request prior to authorizing the transfer of the permit.

TRANSFER TO A REPLACEMENT VESSEL

8494(c)(2)(B) The department may approve the transfer of a California halibut bottom trawl vessel permit to a replacement vessel if all of the following requirements are met:

(i) In the form of a notarized application, the permitholder submits to the department a request for the transfer of a California halibut bottom trawl vessel permit to another vessel owned by the permitholder.

(ii) The permitholder provides a current United States Coast Guard certificate of documentation or vessel marine survey to the department for the permitted vessel and replacement vessel.

(iii) Based on the information provided pursuant to clause (ii), the department determines that the replacement vessel is equal to or less than the capacity of the permitted vessel.

(iv) The department determines the California halibut bottom trawl vessel permit for the permitted vessel is valid and has not been suspended or revoked.

(v) If applicable, the department receives written confirmation from the replacement vessel's owner or authorized agent, or mortgager, of the vessel's participation in the transfer of the California halibut bottom trawl vessel permit.

(vi) The replacement vessel is registered with the department pursuant to Section 7881 at the time the application is submitted pursuant to clause (i).

TRANSFER TO PROPOSED TRANSFEREE

8494(c)(2)(C) The department may approve the transfer of a California halibut bottom trawl vessel permit to another person if all of the following requirements are met:

(i) In the form of a notarized application, the permitholder or his or her conservator or estate submits to the department a request to transfer a California halibut bottom trawl vessel permit to another person.

(ii) If the permitholder's estate submits a request pursuant to clause (i), the estate submits the notarized application to the department within one year of the death of the permitholder as listed on the death certificate.

(iii) A current United States Coast Guard certificate of documentation or vessel marine survey is provided to the department for the permitted vessel and vessel to be used by the proposed transferee.

(iv) Based on the information provided pursuant to clause (iii), the department determines that the vessel to be used by the proposed transferee is equal to or less than the capacity of the permitted vessel.

(v) The proposed transferee meets both of the following requirements:

(I) The person has a valid commercial fishing license issued pursuant to Section 7852 that has not been suspended or revoked.

(IÍ) The person is the owner of a commercial fishing vessel that is registered with the department pursuant to Section 7881 that registration has not been suspended or revoked.

(vi) The permit for the permitted vessel is current, and the permitholder or his or her conservator or estate submitting the application is responsible for any renewal of the permit that becomes due during the application processing period.

(vii) Under penalty of perjury, the permitholder or his or her conservator or estate signs the application for transfer and certifies that the information included is true to the best of his or her information and belief.

DEATH OF PERMIT HOLDER

8494(c)(2)(C)(ii) If the permitholder's estate submits a request pursuant to clause (i), the estate submits the notarized application to the department within one year of the death of the permitholder as listed on the death certificate.
