**1a) Are the objectives and hypotheses clearly stated?**

Objectives of increasing diversity of habitat and evaluating effects of water management and waterfowl use on carbon and nutrient levels in water are clearly stated. Their hypothesis dealing with the sandhill cranes/waterfowl and the carbon/nutrients are clearly stated on pages 7 and 8.
