CHANGE OF OWNERSHIP OF PERMITTED VESSEL

The department shall change the designation of the holder of a permit, and with it shall go all rights, privileges, and obligations of a permit holder, including rights of renewal, upon receipt of a notice of change of ownership to a new owner of a permitted vessel. A permit changed pursuant to this section is valid for the permit year during which it is issued.

Submit the following:

1. Original current Commercial Boat Registration.
2. Original current Salmon Vessel Permit.
3. Copy of proof of ownership in the new owner's name.
4. Copy of the new owner's Commercial Fishing License.
5. Copy of the new owner's Commercial Fishing Salmon Stamp.

TRANSFER TO A REPLACEMENT VESSEL

Submit the following:

1. Original Salmon Vessel Permit Transfer Application signed and dated by all owners.
2. Original current Salmon Vessel Permit.
3. Copy of current Commercial Boat Registration for the replacement vessel.
4. Copy of current proof of vessel ownership for the permitted vessel and the replacement vessel.
5. Copy of United States Coast Guard Certificate of Documentation or survey conducted by a licensed marine surveyor that shows the length, breadth, and depth of both the permitted vessel and the replacement vessel.
6. Copy of replacement vessel owner's current Commercial Fishing License.
7. Copy of replacement vessel owner's current Commercial Fishing Salmon Stamp.
8. Nonrefundable transfer fee of \$200. Payment can be made by check, money order, debit/credit card displaying a Visa or Mastercard logo. Make checks payable to the Department of Fish and Wildlife.

LOST, STOLEN, DESTROYED VESSEL TRANSFERS

The Department shall accept a transfer application within two years after the date that a permitted vessel was lost, stolen, or destroyed. Only the permitted at the time of the loss, theft or destruction of the vessel may apply for the transfer of the vessel permit.

Submit the following:

1. Original Salmon Vessel Permit Transfer Application signed and dated by all owners.
2. Original current Salmon Vessel Permit.
3. Copy of report filed with the United States Coast Guard or any other law enforcement agency or fire department investigating the loss.
4. Copy of current Commercial Boat Registration for the replacement vessel.
5. Copy of current proof of vessel ownership for the replacement vessel.
6. Copy of United States Coast Guard Certificate of Documentation or survey conducted by a licensed marine surveyor that shows the length, breadth, and depth of both the permitted vessel and the replacement vessel.
7. Copy of replacement vessel owner's current Commercial Fishing License.
8. Copy of replacement vessel owner's current Commercial Fishing Salmon Stamp.
9. Nonrefundable transfer fee of \$200. Payment can be made by check, money order, or debit/credit card displaying a Visa or Mastercard logo. Make checks payable to the Department of Fish and Wildlife.

IDENTIFICATION REQUIREMENTS

If the transferee is applying for the first time for a commercial fishing license, they must provide valid identification as defined in Section 700.4, Title 14 of the California Code of Regulations.

- Any license document or Get Outdoors identification number (GO ID) previously issued via the Automated License Data System (ALDS).
- A valid driver's license or identification card issued by the Department of Motor Vehicles or by the entity issuing driver's licenses from the licensee's state of domicile.
- US Military Identification Cards (active or reserve duty, dependent, retired member, discharged from service, medical/religious personnel).
- US Birth Certificate
- US Certificate or Report of Birth Abroad
- Tribal Identification Card, as defined by each sovereign tribal nation
- US Passport
- A foreign government-issued photo identification
- Certificate of Naturalization or Citizenship
- Birth Certificate or passport issued from a US Territory

BUSINESS DOCUMENTATION

If the permitted vessel or the replacement vessel is owned by a business, you must provide documentation showing the business entity type. Acceptable forms of documentation include:

- Articles of Incorporation
- Certificate of Limited Partnership
- Articles of Organization
- Statement of Partnership Authority

PROOF OF VESSEL OWNERSHIP

Pursuant to Fish and Game Code Section 7601, the following may be submitted as proof of vessel ownership:

- United States Coast Guard Certificate of Documentation; or
- California Department of Motor Vehicles Vessel Registration; or
- Out of state vessel registration

CHANGE OF OWNERSHIP

8233.5 Except as otherwise provided in this article, the department shall change the designation of the holder of a permit, and with it shall go all rights, privileges, and obligations of a permit holder, including rights of renewal, upon receipt of a notice of change of ownership to a new owner of a permitted vessel. A permit changed pursuant to this section is valid for the permit year during which it is issued.

FISHING POTENTIAL

8238(b) Commencing January 1, 2020, for applications to transfer a permit to a replacement vessel, the department shall determine the fishing potential of the permitted vessel and the replacement vessel by multiplying the length of the vessel by the breadth of the vessel by the depth of the vessel based on figures provided to the department in a vessel marine survey conducted by a licensed marine surveyor or on a current certificate of documentation issued by the United States Coast Guard.

TRANSFER PERMIT TO A REPLACEMENT VESSEL

8239 A transfer may be approved and a permit issued for use of a replacement vessel pursuant to Section 8241 under all of the following conditions:

- (a) The vessel owner submits a written request for the transfer to the department on a form provided by the department and pays a nonrefundable transfer fee of two hundred dollars (\$200).
- (b) The permit for the permitted vessel is current, and the owner of the permitted vessel makes assurances in the application that any renewal of the permit that becomes due during the application processing period will be made.
- (c) Proof of ownership is submitted to the department for the permitted vessel and replacement vessel.
- (d) The vessel owner submits a vessel marine survey conducted by a licensed marine surveyor or a current certificate of documentation issued by the United States Coast Guard that contains the necessary information for the department to establish that the replacement vessel has the same fishing potential as, or less fishing potential than, the permitted vessel.
- (e) Under penalty of perjury, the vessel owner signs the application for transfer and certifies that the included information is true to the best of their information and belief.
- (f) The same transfer has not been requested within the previous 12 months or the same transfer has not previously been denied and that denial is final, unless the application or supporting information are different than that contained in the previous application, as determined by the department.
- (g) Except as provided in Section 8239.1, the permit has not been transferred to a replacement vessel during the same permit year.
- (h) The permittee has written authority from the legal owner, if other than the permittee or mortgagor, if any, to transfer the vessel permit from the permitted vessel.

LOST, STOLEN, OR DESTROYED VESSEL TRANSFERS

8239.1 Unless otherwise prohibited, the department shall accept a transfer application within two years after the date that a permitted vessel was lost, stolen, or destroyed, notwithstanding any inability to physically examine the permitted vessel to determine its salmon fishing potential. Only the permittee at the time of the loss, theft, or destruction of the vessel may apply for the transfer of the vessel permit. Proof that a vessel is lost, stolen, or destroyed shall be in the form of a copy of the report filed with the United States Coast Guard or any other law enforcement agency or fire department investigating the loss. The department shall only transfer a permit pursuant to this section if the permit remains valid during the entire period following the loss, theft, or destruction, and while the transfer application is pending. If the permittee does not submit a transfer application within two years after the permitted vessel was lost, stolen, or destroyed, or if the department denies the transfer application later than two years after a permitted vessel was lost, stolen, or destroyed, the permit is null and void.

APPEAL PROVISIONS AND DEADLINES

8246.6 If a transfer request is denied, the Department will notify the permittee in writing. The permittee may appeal the denial in writing to the Fish and Game Commission within 60 days from the date of the Department's denial.
