Quantify your assessment and identify the contribution to ERP targets, when possible.# This proposal will collect quantitative information regarding the health and physiological dysfunction of San Joaquin juvenile chinook resulting from elevated water temperatures. This is valuable information in better understanding and managing this run of chinook, which will lead to the development of improved recovery/management measures.*

The goal of the ERP is to recover San Joaquin fall-run chinook salmon.*

This proposal will improve and expand the inventory and monitoring of S.J. fall-run chinook salmon to provide a better assessment of correlation and relationships.*

This proposal may be linked to the following MSCS conservation measures: continue research to determine causes for low outmigration survival of fish from the San Joaquin River, operate hatcheries such that the maintenance of natural populations are not threatened by the release of hatchery fish.*

The proposal will help reduce uncertainties regarding the health effects of elevated water temperatures on hatchery and naturally produced fall-run chinook in the San Joaquin basin. The proposal does not explicitly provide a conceptual model or hypotheses to be tested by the health evaluation. The conceptual model is embedded in the ecological/biological objectives section. Likewise, there is no mention of adaptive management in the proposal, although it is mentioned that results of the study can be used by the California Department of Fish and Game to develop optimal hatchery operations for the basin.*

Focus on aspects of the proposal that may be important to later stages in the project review and selection process.# The proposal could have been improved by presentation of more explicit information regarding the conceptual approach, hypotheses to be tested, and application of collected data to adaptive management. Regardless of these shortcomings, the proposal is good, and its low cost make its funding desirable.*

Provide quantitative support where available (for example, expected increases in population indices, cohort replacement rates, or reductions in mortality rates).# This proposal to evaluate the health and physiological effects (stress, immunodefenses, and smolt development) on Merced River Hatchery chinook salmon of two different elevated water temperature regimes. This proposal can help addresses Merced River Evaluation 1 of the 1997 Revised Draft Restoration Plan (RDRP) for the AFRP to: "Identify and implement actions to provide suitable water temperatures for all life stages of chinook salmon; establish maximum temperature objectives of 56?F from October 15 to February 15 for incubation and 65?F from April 1 to May 31 for juvenile emigration." And more generally, this evaluation is consistent with one of the RDRP objectives to: Collect fish population, health, and habitat data to facilitate evaluation of restoration actions. San Joaquin fall-run chinook salmon that are produced at the Merced River Fish Hatchery are the target of this proposal. This research effort will also link to other temperature evaluation projects, proposals and objectives on the San Joaquin River tributaries and the Delta (K205 and K210). Water temperatures, especially in the fall and spring, are a concern for anadromous salmonid health and condition, and can exert both direct and indirect effects on salmon production. This proposal could help to understand the physiological response to elevated water temperatures of naturallyproduced fish in the Merced River, the southernmost system in the San Joaquin Basin that currently produces salmon. Benefit from this work would come from more specific and protective water temperature management objectives and physical and operational modifications. However, benefits are less certain due to the fact that the investigation focuses on hatchery fish as a surrogate for natural fish, and physiological differences between hatchery and natural stocks are currently unknown. Investigation K210 may assist with clarifying this linkage.*

Specifically identify the status of the species and races of anadromous fish that are expected to benefit from the project, any other special-status species that are expected to benefit, and the ecological community or multiple-species benefits that are expected to occur as a result of implementing the project.# This monitoring work targets fall-run chinook salmon from Merced River Hatchery as a surrogate for naturally produced fish from the same system. Any additional specific water temperature management information resulting from this work would also benefit steelhead through providing specific information that can help with multispecies management.*

duration of benefits to natural channel and riparian habitat values.# This evaluation does not directly restore natural channel and habitat values, but indirectly could promote natural processes. The San Joaquin River and its tributaries have all been so altered that the potential for deleterious temperature effects on the physiological state of juvenile salmon is likely high. The degree of stress and disease that may occur as a result of current temperature regimes remains largely unknown. This monitoring work would help to better understand the physiological state of salmon smolts in the context of elevated water regimes often experienced by many of the juvenile salmon produced in the Merced River. Linked with other water temperature model and operational information this could help lead to contemporary riverine conditions better suited for salmon production.*

Efforts to modify CVP operations include modifications to provide flows of suitable quality, quantity, and timing to protect all life stages of anadromous fish as directed by Section 3406 (b)(1)(B) of the CVPIA, including flows provided through management of water dedicated under Section 3406(b)(2) and water acquired pursuant to Section 3406(b)(3).# This physiological monitoring work, coupled with other temperature investigations, could lead to more specific temperature objectives in the spring during salmon smolt out-migration. One of the mechanisms to improve water temperature in any of the San Joaquin River tributaries is through additional water acquired pursuant to Section 3406 (b)(3) of the CVPIA. Information from this research could lead to more informed decisions about where and when to acquire water under this program.*

Supporting measures include the Water Acquisition Program, the Comprehensive Assessment and Monitoring Program, the Anadromous Fish Screen Program, and others.# As mentioned previously, if a better understanding of the physiological and pathological status of fall-run salmon juveniles in response to water temperature can be developed, it could be one line of evidence used to provide justification for more specific water temperature objectives. A likely mechanisms that could be used to help achieve temperature objectives is water acquired under Section 3406 (b)(3).*

important to later stages in the project review and selection process.# Work similar to what is described in this physiological research of San Joaquin fall-run chinook salmon produced at Merced River Hatchery is needed to better understand potential physiological response of salmon to a major environmental factor, water temperature. This is consistent with Merced River Evaluation 1 of the Revised Draft Restoration Plan for the AFRP, and should be considered for funding under the AFRP. Linkages to other CVPIA supporting measures such as implementation of (b)(3) water are indirect. Benefits to anadromous salmonids could ultimately be realized if improved temperature management results, however, there is no guarantee that this will occur.*
