MANDATORY DEER TAG REPORTING REQUIREMENT

- Successful hunters must report **within 30 days of taking a deer or by January 31** (whichever comes first)
 - Unsuccessful hunters and hunters who held a tag but did not hunt must report by **January 31**
 - Failure to report will result in a \$21.60 penalty fee for the next license year
