## MANDATORY DEER TAG REPORTING REQUIREMENT

- Successful hunters must report **within 30 days of taking a deer or by January 31** (whichever comes first).
  - Unsuccessful hunters, and hunters who held a tag but did not hunt, must report by **January 31**.
  - Failure to report will result in a \$21.60 penalty fee for the next license year.
