Fee includes 5% License Agent Handling Fee and 3% Nonrefundable Application Fee

*A Sport Fishing License and the appropriate validations are required for any person who is 16 years of age or older to take fish, mollusks, crustaceans, invertebrates, amphibians or reptiles in inland or ocean waters.*

*All anglers must have the appropriate report cards in possession while fishing; including anglers 15 years of age and younger, anglers fishing on free fishing days, and anglers who fish from a public pier in ocean waters.*
