Summary of the 2011-12 Pacific Herring Commercial Fisheries in San Francisco Bay

Review of the 2011-2012 San Francisco Bay Pacific Herring Fisheries

QUOTAS

The total fishery quota for San Francisco Bay was set at 1,920 short tons (tons) for the 2011-12 season. This was unchanged from the 2010-11 season quota, which was based on 5 percent of the 38,409 ton spawning biomass estimate for the 2009-10 season. The 1,920 ton quota equaled 3.4 percent of the biomass estimate of 57,082 tons for the 2010-11 season. The 2010-11 season estimate of 57,082 tons was well above the 2006-07, 2007-08, and 2008-09 season estimates of 10,935, 11,190, and 4,833 tons, respectively.

Gill Net Fishery

The total quota for the gill net fishery was 1,845 tons (Tables 1 and 2). This quota was split between the Odd and Even platoons based on the number of permits in each platoon, with the Odd receiving 932 tons and the Even receiving 913 tons.

Fresh Fish Market Fishery

The total fishery quota for San Francisco Bay was set at 20 tons for the 2011-12 season with a maximum daily market order allowance of 1,000 pounds.

Herring Eggs on Kelp (HEOK) Fishery

The total quota for the HEOK fishery was 12.3 tons of product, which was converted from 55 tons of whole fish from the total San Francisco Bay quota. All HEOK permittees must hold a herring permit (i.e. a regular gill net or a CH gill net). Each permittee's share of the herring quota (from the sac roe fishery) is transferred to the HEOK fishery.

SEASON DATES

Gill Net Fishery

The opening and closing dates of the gill net seasons are adjusted each year to account for annual changes in the calendar. Again this season, the DH fishery was integrated into the Odd and Even platoons. The Odd or Even gill net fisheries traditionally open on the second of January or at sunset on the first Sunday in January. This season, the opening was set at 5:00 p.m. on Monday, January 2, 2012. Closing was set at noon on Friday, March 9, 2012. Since 1974, the gill net fisheries have been closed each week from noon on Friday until 5:00 p.m. on Sunday. This weekend closure was instituted to reduce conflicts with recreational users of the bay. Both Odd and Even platoons were closed prior to their scheduled closing dates; the Even reached its quota and the Odd ceased fishing prior to reaching its quota when the herring buyers shut down operations for the season.

Fresh Fish Market Fishery

The fresh fish market fishery season ran from November 2, 2011 to March 31, 2012. These dates were changed from the historic fresh fish market fishery season dates of November 2 through November 15 and April 1 through October 31.

HEOK Fishery

The herring eggs on kelp season began December 1, 2011, and ended March 31, 2012.

The opening and closing dates for the herring eggs on kelp fishery are not adjusted for holidays or weekends.

LANDINGS

Approximately 89 percent of the San Francisco Bay gill net quota (1,634 tons) was landed by the combined platoons during the 2011-12 commercial herring season (Table 1), with both the Even and Odd platoons close to filling their group quotas. The fresh fish market fishery made no landings. There was no fishing effort in the HEOK fishery.

REVIEW OF EACH FISHERY

DH (December) Gill Net Platoon

The DH herring gill net fishery was integrated into the Odd and Even fisheries, with odd numbered DH permits fishing with the Odd platoon and even numbered DH permits fishing with the Even platoon.

Even and Odd Gill Net Platoons

The Even and Odd fishery is divided into two separate platoons grouped by permit numbers that are either even or odd. Platoons rotate fishing weeks with the first platoon to fish determined by whether the season year is odd or even, thus the Even platoon was designated to fish first for the 2011-12 season.

Even Gill Net Fishery

The Even platoon fishery opened on Monday, January 2, 2012, at 5:00 p.m. and made all of their landings during the second and fourth fishing weeks of January (table 3). The quota was reached and the platoon was closed on Wednesday, January 18 at 2:00 p.m. Average roe percentage for the Even platoon landings was 14.5 percent. Fifty-three percent of the permits assigned to this platoon were not used this season.

Odd Gill Net Fishery

The Odd platoon fishery opened on Sunday January 8, 2012, at 5:00 p.m. The Odd platoon made landings each week from the second though fifth weeks of the season and again made landings on the eighth week (Table 4). This platoon was reopened at 12:00 a.m., Thursday January 19; 10 hours after the Even platoon was closed upon reaching its quota. Although the Odd quota was not quite reached, the fleet ceased fishing and the platoon was closed on Friday, February 24 at 12:00 noon. The average roe count for all Odd platoon landings was 15.5 percent. Forty-eight percent of the permits assigned to this platoon did not make landings this season.





FIGURE 1. Quotas and landings for the **herring-eggs-on-kelp (HEOK)** fishery in San Francisco Bay, 1989-90 season through 2011-12 season.


Special Education Permits
