Dear Lifetime Licensee,

This is a courtesy reminder notice from the California Department of Fish and Game (DFG). Every year, hunting items will be available for sale by April 15 and Lifetime Hunting Licensees can claim their annual hunting license at no cost. Please note that you will NOT receive any further reminder notices; just claim your license every year.

Because of federal survey requirements, and the need for accurate information from all licensees on an annual basis, lifetime licensees are required to verify that their information is current each year before their licenses are renewed. Your license can be claimed at any DFG license sales office, license agent, online or by telephone. At the time you claim your license, you will also be able to purchase additional license items that are not included with your lifetime license package.

As a Lifetime Hunting License holder you are entitled to a California hunting license each year for life.

Lifetime licensees, who possess the Lifetime Privilege Package – Bird Hunting, and are 16 years of age or older, are entitled to Upland Game Bird and California Duck Validations each year for life. You can claim your California Duck and Upland Game Bird Validations at the time you claim your license. However, to receive your collectible 2012 California Duck and Upland Game Bird Stamps, you must claim them at www.dfg.ca.gov/licensing/collectorstamps.

Lifetime licensees, who possess the Lifetime Privilege Package – Big Game Hunting, and are 12 years of age or older, may claim a First Deer Tag or First Deer Tag Drawing Application when claiming their hunting license. You may also claim up to five Wild Pig Tags. Please be aware that you can claim your hunting license and defer making your hunt choices to a later date (before June 2 for the big game drawing).

Using the identification number at the top of this letter, you can update your customer record and claim your hunting license and additional items from:

Lifetime licenses and additional privileges claimed via the DFG website will be mailed to customers. Please claim your license early to allow for receipt of your license prior to the start of the license year.
- **Telephone sales at (800) 565-1458**
Lifetime licenses and additional privileges claimed via telephone will be mailed to customers. Please claim your license early to allow for receipt of your license prior to the start of the new license year.
