Customers must have hunter education on their profile to purchase hunting items.

Customers without hunter education on their profile must present an acceptable form of hunter education to a License Agent or CDFW sales office.

Hunter Education Document Selection

When entering hunter education, License Agents must ensure that the correct type of document is selected from the dropdown box on the sales terminal.

California Hunter Education – issued through a verified California hunter education course.

Out-of-State Hunter Education – A hunter education certificate issued by a state outside of California.






Previous CA Hunting License – A previous year’s Hunting License issued by the state of California.

Out-of-State Hunting License – A hunting license issued to a customer within the past 2 years.
