- 5. \$15.00 entry fee (cash, please)
- 6. Warm clothing / raingear depending on weather. (It is always cold in the morning.)
- 7. Good footwear for the field (high probability fields will be damp or wet)
- 8. Shotgun
- 9. Shotgun shells (#6 size recommended for pheasant. 1 box for practice and hunting)
- 10. Shooting or safety glasses (some will be onsite for loan if you do not have your own)
- 11. Ice chest with ice

You may also wish to bring a camera to record your day.

The hunt will be held rain or shine. Registration is 7:00 to 7:30. Please plan your travel to be on time. Orientation begins promptly at 7:30.

There are still a couple of spaces available. If you know someone else who might be interested in this hunt, please have them contact me. If your plans change and you are unable to attend the hunt, please call so we may offer this opportunity to someone else. I look forward to seeing many of you again and meeting our new participants. Camatta Ranch, Camatta Creek Road off Hwy 58, San Luis Obispo County


Driving Hwy 101 from the south: Take Hwy 101 north to the town of Santa Margarita, approximately 8.5 miles north of San Luis Obispo. Take Exit 211 onto Hwy 58. Go approximately 1.5 miles, through town, then turn right to stay on Hwy 58. Watch the signs - Hwy 58 turns left after you leave town. Follow Hwy 58 for approximately 22 miles. (You will pass intersections with Hwy 229 to Creston, La Panza Road and Shell Creek Road on the way out.) Turn left on Camatta Creek Road. Plan on about a one hour drive from San Luis Obispo.

Driving Hwy 101 from the north: Take Hwy 101 south to Atascadero, approximately 10 miles south of Paso Robles. Take Exit 219. Turn left onto Hwy 41 East. Go through town and continue on Hwy 41 for approximately 10 miles. Pass the turn off for Creston (Hwy 229), go over Huerhuero Creek and turn right onto La Panza Road. Go 10 miles. At the stop sign, turn left onto Hwy 58. Go approximately 6 miles. Turn left on Camatta Creek Road. Plan on about a one hour drive from Paso Robles.

Driving Hwy 58 from the east (Carrizo Plains/Soda Lake Road): Follow Hwy 58 west approximately 20 miles past Soda Lake Road in the Carrizo Plains. Turn right onto Camatta Creek Road. Plan on about a 30 minute drive from Soda Lake Road.

I further acknowledge that b providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe me any duty whatsoever to supervise or control the actions of myself or other persons participating in, watching the activity or on the property.
4. Waiver And Release Of Claims: I hereby expressly waive any right that I might have to sue the State, its agent employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that I might suffer as a result of participating in hunting activities on State property.
5. Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting State property described above, I further acknowledge that serious injuries or death may be caused by the negliger acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree to assume the risk that I may be seriously injured or killed through the negligent acts of others. I agree to waive any right I may have to sue the State, its agents, employees and/or volunteers for injuries or death that I may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. LAZY ARROW GUIDE SERVICE PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGMENT OF RISK

In consideration of the services of **Lazy Arrow Guide Service**, their agents, owners, officer, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "**L.A.G.S.**"), I hereby agree to release and discharge **L.A.G.S.**, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

- 1. I acknowledge that my participation in outdoor adventure based activities such as guided hunting, horseback trail rides, wagon tours, and mountain bike tours entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
 - Furthermore, **L.A.G.S.** guides have difficult jobs to perform. They seek safety, but they are not infallible. They might be ignorant of a participant's fitness or abilities. They might misjudge the weather, the elements, or the terrain. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
- 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless **L.A.G.S.** from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of **L.A.G.S.**'s equipment or facilities, including any such claims which allege negligent acts or omissions of **L.A.G.S.**
- 4. Should **L.A.G.S.** or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
- 6. In the event that I file a lawsuit against **L.A.G.S.**, I agree to do so solely in the state of California, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against **L.A.G.S.** on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and agree to be bound by its terms.
