# CDFW's Mission

To manage California's diverse fish, wildlife and plant resources, and the habitats upon which they depend, for their ecological values and for their use and enjoyment by the public.

# About the Reserve

- BMER is owned by the State Lands Commission and leased to CDFW for management, operation and maintenance.
- In 2004, the Fish and Game Commission formally designated BMER as an ecological reserve.
- BMER is home to many rare plants, including one of the state's last significant stands of maritime chaparral.

# A little history ...

- In 1990, a Unocal construction project resulted in major damage and alterations to the lands in this area. The BMER property was specifically set aside as mitigation for these damages.
- The mitigation agreement stipulates that “the use of the property shall be limited to natural open space for habitat protection, education, research and resource conservation uses....”

# CDFW Responsibilities

- As stated in Title 14, CCR section 630, the Reserve allows access for pedestrians and hikers from sunrise to sunset. Activities that could have a detrimental effect on the land – specifically horseback riding, mountain biking and the flying of small aircraft – are prohibited.

Understaffing has limited CDFW's ability to enforce the rules over the last decade.

# What cycling does to the Reserve

- Damages topsoil.
- Causes soil compaction and loss, which changes the way water is absorbed, particularly on uneven terrain.
- Encourages mass erosion.
- Disrupts wildlife movements – many animals are active during evening hours or at night.
- Damages protective bark on tree trunks when riders continually ride over them.
- Pushes walkers and hikers off-trail.

# What altering vegetation does to the Reserve

- Removes protective layers of shade for sensitive plants and animals.
- Exposes area beneath trees to heat, which can burn other vegetation and damage the nutrient value of the soil. This can impact the plants' ability to survive.
- Impacts animals' ability to obtain food when the landscape is altered or removed.
- Increases water runoff from trails and degrades watershed functions for the ecosystem.

- Access the reserve on foot between sunrise and sunset.
- Walk and hike on designated trails.
- Bring dogs as long as they are retained on a leash of less than 10 feet.
- View wildlife at a safe distance.
- Please carry out all refuse and leave the reserve as you found it.

## YOU MAY NOT:

- Ride or operate a bicycle.
- Ride horses.
- Hunt.
- Operate any motorized vehicle or small aircraft.
- Disturb birds, nests, eggs or any other form of plant or animal life.
- Feed the wildlife.
- Collect specimens, except by permit.
- Release any fish or animal, including domestic species.
- Fire or discharge any weapon including a firearm, bow and arrow, air/gas gun or spear gun.
- Start or maintain any fire or light fireworks or other explosive or incendiary devices.
- Camp overnight.
- Swim, wade, dive or use any diving equipment.
- Launch or operate a boat.

- Enjoy the reserve with uses that are compatible with the primary purposes of the reserve.
- View wildlife at a safe distance.
- Please carry out all refuse and leave the reserve as you found it.

## YOU MAY NOT:

- Ride or operate a bicycle.
- Ride horses.
- Operate any motorized vehicle or small aircraft.
- Disturb birds, nests, eggs or any other form of plant or animal life.
- Feed the wildlife.
- Collect specimens, except by permit.
- Release any fish or animal, including domestic species.
- Fire or discharge any weapon including a firearm, bow and arrow, air/gas gun, or spear gun.
- Start or maintain any fire or light: fireworks or other explosive or incendiary devices.
- Camp overnight.
- Swim, wade, dive or use any diving equipment within the reserve.
- Launch, or operate a boat within the reserve.

MAXIMUM FINE OF \$1,000.
