COSUMNES RIVER TURKEY HUNTS ADDITIONAL INFORMATION

Enclosed you will find a map to the hunt check station. A specific hunt area will be assigned to you when you check in. There are no pre-existing blinds at the hunt areas. Hunters must supply their own blind materials, decoys, and calls. All hunters must show valid hunting license. Upland game bird validation only required for adult hunters. Mobility-impaired hunters may bring up to two non-hunting guests if additional assistance is required. Check-in at Dillard will begin approximately one and one-half hours (90 minutes) before shoot time, and check-in at Arno and McFarland will begin approximately one and three-quarter hours (105 minutes) before shoot time. Shooting hours are from 1/2 hour before sunrise to 1:00pm. So as not to disturb hunters that are already hunting, entry on to the hunting area will not be permitted more than one hour after shoot time begins!!

Please note that each member of your party must hunt together in the assigned area. Hunting partners that separate will lose their privileges to hunt. Scouting prior to the hunt is not possible as this property is not open to the public other than for the hunt day. If you see unauthorized hunters please let the check station operator know immediately so that law enforcement officers can respond. If this hunt is successful this year, the Preserve will consider continuing and this opportunity in future years.



The Ten Commandments of Firearms Safety:

- 1. Watch that muzzle! Keep it pointed in a safe direction at all times.
 - 2. Treat every firearm with the respect due a loaded gun.
- 3. Be sure of your target and what is in front of it and beyond it.
- 4. Keep your finger outside the trigger guard until ready to shoot .
 - 5. Check your barrel and ammunition.
 - 6. Unload firearms when not in use.
 - 7. Point your firearm only at something you intend to shoot.
 - 8. Don't run, jump, or climb with a loaded firearm.
 - 9. Store firearms and ammunition separately and safely.
- 10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.
