# 4. Suggested Policies of Wildlife Conservation Board

Mr. Horn suggested that because the Commission had no representative on the Board and three of the Interim Committee Members were absent this item be held over. The Board instructed this item will be considered at a future Board meeting.

# Naming Project when Land is Deeded to State as a Gift

The problem of the naming of a project as requested by a donor when the land is deeded to the state as a gift was discussed by Mr. Horn. A pioneer family on the Mendocino Coast has considered deeding a fine parcel of beach to the state for a fishing access and would like to have the area bear the name "HEESER DRIVE" in honor of the family. The Chairman asked if the family is well-known and respected in the area and was assured that this is indeed true.

The Board felt that so long as it is in the best interest of the sportsmen and a donor wishes to deed a parcel of land having high recreational value to the state, the Board should favorably consider the donor's suggested name for the project.

# 6. Clear Creek Fish Ladder, Project No. 96

\$43,000.00

On November 28, 1951 the Board allocated \$50,000.00 for construction of a fish ladder at the McCormick-Saeltzer Dam on Clear Creek in Shasta County. A long series of negotiations between the owners of the dam, the Department of Fish and Game, and the Attorney General have now been resolved into an acceptable agreement.

Surveys and studies by the Division of Architecture and the Department of Fish and Game developed revised plans for a tunnel type ladder at an estimated cost of \$81,000.00 (as of January, 1956).

Such a ladder would make ten miles of the best spawning area of Clear Creek available. A "Report on Clear Creek, Shasta County, with Reference to Fishway Project on McCormick-Saeltzer Dam" by George Warner of the Department of Fish and Game, indicates that such a project and expenditure is justifiable. (A copy of this report was furnished to Board members and is filed for reference in the files of the Department of Fish and Game.)

Messrs. C. O. Elliger and W. J. Rosskopf of the Division of Architecture appeared, explaining the proposed tunnel would be about 255 feet long, that additional concrete structures would occur at each end, outlined some of the details of construction at the dam, gave a breakdown of cost estimates and outlined the public safety features that would be required.

Mr. Lowery asked if cost of operation and maintenance would be borne by the land owner.

Mr. Gordon stated that such costs would be borne by the Department of Fish and Game.

Discussion developed information to show that adequate water would be released under Trinity River Project to support a fishery, and that salmon and steelhead trout successfully use tunnels and tunnel-type ladders.

Senator Brown raised questions regarding the cost of construction and Mr. Elliger gave a breakdown of costs.

Mr. Horn stated that of the initial \$50,000.00 allocated by the Board on November 28, 1951, \$7,500.00 has been expended in surveys and engineering studies leaving a balance of \$42,500.00.

Because construction costs have increased since the Division of Architecture's estimate it was recommended that an additional sum of \$43,000.00 be allocated from the unallocated balance of the Wildlife Restoration Fund for construction of this fishway. The project appears fully justifiable, and operating and maintenance costs to the Department of Fish and Game will be low.

The Department of Fish and Game recommended this project for consideration by the Board.

# 7. Lindo Lake Public Fishing Area, Project No. 77

The Board allocated a total of \$19,000.00 on November 28, 1951 for this project. Following failure to secure sufficient water from wells, and after study by the County of San Diego and the Department of Fish and Game, the Board allocated an additional \$4,500.00 on March 24, 1955 to compact the lake bed, install a pipeline and meter, and to purchase water from available sources to fill the lake. San Diego County would then maintain the water-level in the lake. \$1,200.00 of the \$4,500.00 was for the purchase of water for the initial filling of the lake.

An agreement was entered into between the Department of Fish and Game and San Diego County whereby the county would do the necessary work, purchase the estimated quantity of water to fill the lake, and be reimbursed for costs.

San Diego County completed all requirements of the agreement excepting that the lake has not been filled. The county purchased the estimated amount of water and placed it in the lake.

Additional water cannot be purchased at this time. Due to a severe and critical water shortage, some communities in San Diego County now have water rationing. The City of San Diego normally operates with a seven-year reserve water supply but now has about a sixmonths supply in storage.

The county has requested payment of \$4,476.87 under the agreement, but the Legal Adviser of the Department of Finance has ruled that payment cannot be made under the existing agreement because the lake is not full.

Mr. Horn reported that Lindo Lake is similar to any other projects in Southern California that require water. Owing to a fourteen year progressive drought, water isn't available. Only a change in the cycle of precipitation can change conditions.

In view of these conditions it was recommended that the Wildlife Conservation Board authorize the Department of Fish and Game to modify the agreement with San Diego County so as to meet the legal requirements and pay the county for expenditures made and work done.

9. Approval of Fund Transfer - Mojave Hatchery Well - Project No. 3439 - 12-11

On January 5, 1956 the Board allocated \$19,500.00 for a new well at Mojave Fish Hatchery. Bids received exceeded this amount. The low bid was \$19,700.00 and there was an expenditure of \$106.78 for bid advertising - making a total cost of \$19,806.78 and leaving a deficit of \$306.78.

In order not to let the bid expire by waiting for a Board meeting, the Coordinator advised the Administration of the Department of Fish and Game to take this amount from an un-earmarked balance of funds previously allocated to the Mojave Hatchery.

It was requested the Board approve this transfer of funds within the project.

Assemblyman Erwin stated this transfer of funds be approved, and advised the Board that certain groups in Southern California were issuing publicity claiming the Board was not considering Southern California problems. He stated the claim has been made that the Board had withdrawn the \$100,000.00 allocation for Bixby Slough.

The Coordinator advised the Board that this allocation still remains. Assemblyman Erwin further referred to such criticism as misleading, that every effort has been made by the Board to get sound projects throughout the state, and projects in Southern California that were judged to have a chance of functioning have been approved, though some of them are of limited value.

Assemblyman Erwin referred to Mojave Hatchery as one providing fish for Lake Arrowhead and Big Bear Lake, and the Owens Valley Hatcheries that provide so much fishing recreation to Southern California residents.

# 10. Mojave and Fillmore Fish Hatcheries

# Mojave Hatchery - Project No. 39 Fillmore Hatchery - Project No. 38

\$45,000.00

Ground water levels at both of these hatcheries have been falling during the present period of sub-normal precipitation. One well motor at Mojave Hatchery burned out as a result of the overload and was rewound. The 75 HP motors at wells 3 and 4 at Mojave are now forced to operate at about 100 HP rating. They might fail at any time.

One well at Fillmore Hatchery is now out of production because of the falling water table.

The Department of Fish and Game proposed a modification at Mojave, by replacing the existing 75 HP electric motors with 125 HP ones, new 200 HP gasoline standby engines, new pumps, shafts, columns, etc., so as to produce 3,000 g.p.m. per well at 100 ft. pumping level with a 120 foot bowl setting in wells 3 and 4.

The Department of Water Resources again studied the problem and concur in the adequacy of modification suggested by the Department of Fish and Game.

The Department of Water Resources Report cites such lowering of water levels at both the Mojave and Fillmore areas in the past, and predicts that water levels will raise at Mojave with increased precipitation and at Fillmore with increased rainfall and operation of San Felicia Dam.

In general discussion Mr. Lowery pointed out that Mojave Hatchery had been constructed with Wildlife Restoration Fund, and Fillmore with department funds. He felt that operation and maintenance of Fillmore should be a department responsibility.

Mr. Erwin felt Mojave should have the new pumps, etc.

# 11. Boutcher's Gap Access Road - Project No. 1014 \$52,000.00

The County of Monterey through its Board of Supervisors and Planning Commission, various Sportsmen's organizations, and the Boy Scouts of America, all asked the Wildlife Conservation Board to consider taking over and improving a road that now leads from Highway No. 1 at Grimes Ranch up Palo Colorado Canyon to Boutcher's o Gap, but emal bes half and it med is froque of yound ed blow meet the needs of the hatchery but did not feel it should come out

About four miles of this road was constructed by the Boy Scouts and is closed to public use by virtue of a use agreement with the land owners. A blockade is maintained at the west end of this segment of the road, and prevents hunters, fishermen and all other recreationists from reaching a 60,000 acre wild area in Los Padres National Forest.

This blocking of the road causes a very bad pile up of cars at the barricade during the hunting and fishing season when sportsmen endeavor to get into this vast wild area. Togo di vaendos di sand

This proposed project is a cooperative, coordinated, community endeavor. The Boy Scouts of America relinquished their right-of-way easement, and secured an easement for the State of California from the three owners, for a 40-foot right-of-way plus such additional width as would be necessary for cuts and fills.

The County of Monterey made a survey of the road, developed plans and cost estimates, and the Board of Supervisors passed a resolution agreeing to do the work, and to operate and maintain the road when completed as part of the county road system.

Senator Fred Farr and Assemblyman Pattee secured an agreement from the United States Army stating that the Army would construct the road without cost, if the necessary material could be furnished by the state or county.

The United States Forest Service Regional Office at San Francisco has agreed to construct a suitable public campground at the Boutcher's Gap end of this road.

The Chairman called upon Assemblyman Allan Pattee of Salinas, Monterey County, who stated that the road meant a great deal to all residents of Monterey County and that it would provide access to a magnificent region and some of the finest stream fishing and deer hunting in the country. It can be made into a recreational district for people of all the state. The existing Boy Scout Camp in the area is a model for all the United States. The people of Monterey County are back of the project 100 percent.

# Boutcher's Gap Access Road (Contd)

Mr. Tavernetti, a member of the Monterey County Planning Board, corroborated Mr. Pattee's statements and added that the county is very anxious to open the forest area to hunters, fishermen, and other recreationists. This access road would be a big help and the county would willingly take over all operation and maintenance of the road if it is built.

Mr. Lowery asked about the ownership status of the lands in question.

Assemblyman Pattee stated that the road from Highway 1 to the existing blockade was county road. The four miles considered in this proposal would be across private land and would end at the National Forest Boundary at Boutcher's Gap. The owners of these lands have already executed grants of right-of-way, and these documents are duly recorded.

The Forest Service Camp would be on Forest land.

It was recommended the Board allocate the full \$52,000.00 for this road from the unallocated balance of the Wildlife Restoration Fund and authorize the Department of Fish and Game to enter into an agreement with Monterey County for construction, operation and maintenance. Any work done by the Army will be without cost and any funds thus saved may be recovered by the Wildlife Conservation Board.

# 12. Inland Angling Access Program

The Coordinator reported that, in accordance with authorization by the Board a survey has been made of potential fishing access sites along the Sacramento and San Joaquin Rivers and the Delta from Shasta Dam to a point west of Modesto. Over 80 sites have been selected for consideration. Priorities have been assigned based upon fishing potential as related by fishermen, department personnel and other sources.

Not all of these 80 sites are necessary, and some of them cannot be secured, because land owners do not desire to sell parcels of their property. Priority of sites is based upon location and proximity to centers of population, fishing riffles on the river, and ready access from nearby existing public roads.

Considerable public land, either in Federal, state, county or city ownership was located and wherever possible, arrangements were made to utilize this public land, thus eliminating the necessity of land purchase. Where no public land was available, purchase negotiations have been initiated.

For all sites presented for Board consideration at this meeting, either counties or cities have, through official action of their Boards of Supervisors or Councils, agreed to assume the operation and maintenance of these areas. In some instances the counties have agreed to do all or part of the construction on a cost reimbursement basis. There will be no cost of operation or maintenance to be met by the Department of Fish and Game.

Necessary engineering work has been done, and cost estimates prepared for eight sites presented to the Board at this meeting. Such engineering and estimating is continuing on other sites and these will be presented to the Board for consideration at the next meeting.

Mr. Ray Nesbit presented the following three access sites:

#### 1. Keswick Reservoir Inland Angling Access

This site is located at Keswick Reservoir in Shasta County. This body of water is about one-half mile wide and ten miles long. It has been stocked with fish and an excellent fishery is reported, but no public access or boat launching facility is available. The United States Bureau of Reclamation has agreed to furnish to the state, without cost, a long-term lease on the land required for such development. The County of Shasta has agreed to maintain and operate the facility, and to take the access road necessary to the project into the county road system. The designs are complete. Facilities to be developed are as follows:

# Facilities:

(1) Concrete launching ramp

(2) Float and Gangway

(3) Road grading and paving
(4) Parking area grading and surfacing
(5) Drainage culverts

(6) Guard rails

(7) Sanitary facilities

Total estimated cost of project \$48,295.00.

Maps and diagrams of the area were studied by the Board.

Mr. John Reginato - General Manager, Shasta-Cascade Wonderland Association stated that no public launching facilities existed from Shasta Dam to Redding. One ramp existed in Redding and then none until the river reached Red Bluff. During the period of low flow the river carries 4500 sec. feet of water and under these conditions boats cannot navigate from Redding to Red Bluff. A series of launching ramps as proposed would permit fishing all segments of the river. The Shasta County Board of Supervisors have endorsed this program and agreed to undertake the operation and maintenance of those sites developed in Shasta County.

An adjacent county park has adequate sanitary and other recreational facilities which would enhance the ramp development. This reach of the river provides some of the finest fishing in the river and would be made more available to the public through this development. Inadequate launching facilities exist at present, and interest in this project is high.

The County of Tehama has agreed to operate and maintain this proposed facility at no cost to the state. The facilities proposed with their cost estimates are as follows:

The Boat Club requested this cancellation of their lease.

# 13. Archibald Lake Public Fishing Area (no) seed grand of allies exal bladtdork

Mr. Nesbit stated that only a status report would be presented, and no request would be made for funds at this meeting.

This reservoir site is located in Sections 26, 27, 34 and 35, T 10 S, R 18 E MDB&M at 300 ft. elevation, five miles northeast from Madera in Madera County. The proposed lake will impound 4,700 acre feet of water and cover nearly 400 surface acres. Average depth of water will be approximately twelve feet. Water will be provided by natural drainage from 1,000 acres of watershed and by pump diversions from winter surplus flows from the Fresno River. Water also could be delivered by gravity flow from the Madera Canal (CVP) if necessary or desirable, and if a surplus exists.

Ownership of the land is in one party and the County of Madera has taken an option for the purpose of assigning it to the state. It has been determined that approximately 1,100 acres are required for the project.

In March, 1956, Mr. Harry Barnes, a well-qualified civil and hydraulic engineer, was hired on a consultant basis to make a study of the project. He made preliminary cost estimates, water requirement and availability of water studies. His report dated May, 1956, indicated the project was feasible contingent upon detailed soil tests, designs, costs and confirmation of water rights. The Madera Irrigation District owns the major share of the vested water rights in the Fresno River. The Madera Irrigation District Board of Directors has stated they favor the project and will not protest a state application for water for the project. The plan is to divert water into the lake during the period of surplus water flows. The Madera Irrigation District has also agreed to sell, at ten cents per acre foot, any surplus water they may have which would not otherwise be available under the state filing. This would be a supplemental supply if required.

The County of Madera Board of Supervisors has passed a resolution recommending the project and has agreed to construct all access roads to the project as well as to operate and maintain the project, if and when constructed. In anticipation of this project the County of Madera has appropriated in excess of \$10,000.00 for outlay not possible by the state, and has established a recreational department.

Practically all sportsmen's clubs, service clubs and other groups have endorsed the project. The city council of Madera has approved the project. It is highly needed in the area because of the lack of local warmwater fishing and the over-crowded conditions of the more remote fishing areas, such as Yosemite Lake and Bass Lake.

Preliminary cost estimate of construction and land purchase of 1,100 acres, is approximately \$240,000.00.

Because of the magnitude of this project, approval was requested of the Wildlife Conservation Board, and authorization to proceed with land appraisals, soil tests, designs and water right filings. No allocation necessary at this time for the above work, as these expenditures can be taken from Project No. 2500.

Senator James A. Cobey of Merced stated, "Madera County is badly in need of this type of recreational facility. The City and County of Madera are solidly united in a request that this project be put through with all possible dispatch."

Senator Cobey then introduced Lyman Patterson, Director of Recreation and Parks, Madera County; H. A. Dimaline, Secretary Manager, Madera Chamber of Commerce; Mayor Albert Barsotti, City of Madera; Clyde A. Cavin, President, Madera Irrigation District, and Lester J. Gendron, Madera County District Attorney.

Mr. Gendron, as spokesman for this group stated:

"Archibald lake with 400 surface acres of water and 1,100 acres in the total project would be an excellent recreational area. It is located in the center of the state, and the only similar area in the locality is Yosemite Lake which 270,000 people use annually, and these facilities are badly overtaxed."

The County has done everything possible to foster this project. A contract has been drawn with the Madera Irrigation District to purchase surplus water. The Irrigation District will impose no objection to the Department of Fish and Game filing on surplus seasonal water in the Fresno River. The county will undertake such development as the Wildlife Board cannot finance. The County Board of Supervisors will construct access roads leading to the property and will operate and maintain the project if constructed.

General discussion brought out that little or no flood control benefits would accrue from the project. That the average depth would be about 13 feet, with a maximum of 23 feet at the dam. Also that the Department of Fish and Game Fisheries Managers state the lake would present excellent conditions for warmwater fish, with suitable temperatures.

Senator Johnson asked if this lake would be in conflict with any other water uses.

Senator Cobey replied that the Archibald Lake proposal would not conflict with any other use of water on the Fresno River.

Mr. Silva asked if it is planned to set up Archibald Lake as a fishing or general recreational lake.

Senator Cobey replied that the primary purpose would be for warm water fishing and other recreational use would be subordinate to that purpose. Use of high-powered motor boats or water skiing would not be permitted. So far as Madera County supporters of the project are concerned the state could write its own ticket.

Mr. Lowery pointed out that picnickers and bathers would constitute 50% or better of the users, and that serious consideration must be given to methods of handling all phases of recreation on a statewide basis.

Mr. Gordon referred to the name "Archibald Lake" stating it did not locate the lake.

Mr. Lowery suggested the Board staff look into getting federal funds such as Dingell-Johnson money for projects of this sort.

During June of 1955 the Coordinator made a trip to Los Angeles, spent several days with city officials including the city attorneys, drawing up an agreement that was tentatively accepted by the department and sent to the city for signature. Appraisals of the property to be purchased by the state were made, and an attempt made to purchase that portion from the city per previous agreement. The agreement as developed with the city called for development of the state purchased portion for public fishing.

# 14. Request of Ocean Fish Protective Association for Helicopter

#### Historical

The Ocean Fish Protective Association and the California Wildlife Federation (by Resolution passed October 15-16, 1955, at Marineland, California) again urged the purchase of a helicopter for use of the Department of Fish and Game, especially for marine patrol over Southern California waters.

Through efforts of the Ocean Fish Protective Association the Wildlife Conservation Act was amended in 1953 so that the Wildlife Conservation Board may purchase boats, aircraft and equipment for improvement and protection of marine

The Wildlife Conservation Board briefly considered this request October 13, 1953, recommending that the item should be placed in the Fish and Game Budget. This item in the 1954-55 Budget was deleted by the Department of Finance. A bill for purchase of a helicopter failed to pass in the 1954 Legislature.

# Department Recommendation

Revised figures were secured from both Bell, and Hiller Helicopter manufacturers and all data was presented to the department. After careful consideration by Director Gordon and his staff, Mr. Gordon stated, "While we realize the need for more constant and increased patrol to control violations in our coastal waters, the Department at the present time

cannot afford to expend an additional \$25,000 to \$30,000 annually to maintain and operate a helicopter. This also would be contrary to the commission's resolution on further Wildlife Conservation Board expenditures that would materially increase operating costs."

#### Coordinator's Recommendation

Because of the commission's resolution, the department recommendation and the unbalanced department budget, we cannot recommend the purchase of a helicopter by the Wildlife Conservation Board at this time.

However, it is recommended that the Department of Fish and Game and the commission make a very factual study of the use that could be made of aircraft, not only for patrol but also for certain phases of marine fisheries research. Perhaps some phases of such research work could be done much cheaper with aircraft than with surface vessels, and an expensive-to-operate vessel might be retired.

Before we dismiss the idea, let us not forget that only a few years ago the planting of fish by airplane was declared impossible! Now it saves many dollars - and does a better job.

Mr. Fritz Mangold, Executive Secretary of the Ocean Fish Protective Association, speaking for that organization, partially concurred in the report on this item and stated that paragraphs 2 and 3 of the Coordinator's recommendation answer the problem.

# 15. Program Regarding Inland Fishing Access

Mr. Horn advised the Board that the program of access to inland fishing waters has met with widespread public approval. Many communities, other than those along the Sacramento-San Joaquin Rivers are definitely interested and have asked for consideration.

Requests for access development have been received from the cities of Richmond, Berkeley, Alameda, several points in Marin County, on Shasta Lake, the American River, the upper Sacramento River above Shasta Lake, and on the Klamath River.

Considerable discussion developed.

Mr. W. M. Mason, Director of Planning, City of Richmond, Mr. Robert Venable, City of Alameda, Mr. Robert Hunt, President of Richmond Rod and Gun Club, all presented statements of the needs and plans for their respective areas.

Assemblyman Lowery discussed the problem of recreational development statewide and stressed the need for a definition of administrative responsibility and jurisdiction by various state departments.

Mr. Lowery expressed a fear that too much money would be expended on surveys of such proposed projects.

Mr. Horn advised that with Board approval Mr. Russell Sturges was hired as a Special Consultant for a nine-month period. He completed the survey and selection of sites on the Sacramento-San Joaquin Rivers and the Delta in six months, and was now working with engineering crews to complete data necessary to present all sites to the Board.

The Coordinator requested approval from the Board to hire Mr. Sturges for another nine-month period, beginning either January 1, or February 1, 1957.

Assemblyman Lowery stated that in his many contacts with people along the Sacramento River he had not heard one adverse comment about Mr. Sturges or his work, and had heard many complimentary remarks.

Senator Ed. Johnson corroborated Mr. Lowery's statements.
