Mr. Nesbit reviewed the action taken by the Board previously on this project. He advised that the project was approved by the Board at the February 14, 1961, meeting and an allocation of \$31,400 was made. This amount included \$4.800 for land acquisition of 4.44 acres and \$26,600 for development.

Title problems delayed acquiring land and obtaining construction bids for more than a year. Increased construction costs over this period of time made it necessary to design the access road and parking area to very minimum standards to carry out development within the funds allocated. The original estimates apparently were very tight in relation to construction costs at the time they were made. Mouth of Chico Greek Angling Access Project

The proposal calls for development of a small lake for fishing and other recreational use in extreme northeastern Mendocino County. This site is at about 3,600' elevation in the Mendocino National Forest on the drainage of the middle fork of the Eel River. This area of the Coast Range is deficient in lakes or reservoirs for fishing waters, but has a high potential for such recreational use.

The lake would entail off-stream storage utilizing an existing basin which now has only an intermittent pond due to a small watershed. Development would consist primarily of a small diversion structure on Hammerhorn Creek and approximately 1/2 mile of pipeline through which a portion of the stream flow would be diverted to fill the basin. Any overflow would be drained back into Hammerhorn Creek. A sew series an ideas and make an entire and

To make the lake as large as feasible, a 5' levee to raise the natural dike forming the basin is planned by the U.S. Forest Service. This will form a lake of about 10 surface acres with a maximum depth of 25-30 feet, and a storage of approximately 100 acre feet.

The Department of Fish and Game believe that the impoundment will provide either a trout fishery or a desirable warmwater fishery.

The County of Mendocino has agreed to assume maintenance for the pipeline and other project developments constructed by the State, as well as handling construction thereof on a reimbursement basis. This appears to be the most feasible construction procedure.

The U. S. Forest Service plans to cooperate substantially in the proposed project through providing access roads, campgrounds, clearing of the lake basin, and obtaining water rights. A HELD TO THE WAY THE CAA

Mr. Nesbit advised that the County of San Diego Fish and Game Commission has proposed two artificial reefs to be located along the San Diego coastline. One of these reef sites has been surveyed and recommended by the Department of Fish and Game biologist-divers. The other reef area is proposed for evaluation during 1963. The Ocean Fish Protective Association has given strong support of these projects and like the Department of Fish and Game believe they have considerable value in providing better ocean fishing. A wanted alder

This reef would be constructed of quarry rock which has proven the most feasible of materials. Buoys would be anchored at the reef so that it can be easily located by fishermen. The reef placement would be done under the supervision of the biologist-divers of the Marine Resources Operations section of the Department of Fish and Game. The County of San Diego has agreed to maintain the anchors and buoys after the reef has been placed and has already appropriated funds for maintenance.

The proposed location for this reef is in 60' of water about one mile offshore in a northwesterly direction from the Scripps Institute of Oceanography pier. The cost estimates are as follows: Tol Bernoolla ed Collate to Mile terrespor

Mr. Luevano asked if these reefs would become a hazard to navigation. Mr. Nesbit advised that there would be no navigational hazard created by these reefs. He elaborated by stating that permits and approval of plans must be secured from the State Lands Commission, the Navy, and the Corps of Engineers, prior to reef construction. This particular reef is planned for construction in 60 feet of water and would project up off the ocean floor perhaps 6 or 8 feet. It was also pointed out that construction of these reefs in barren sandy. bottoms creates artificial habitat which concentrates the fish.

Facilities would be jointly on property of the U.S. Forest Service and the P.G.&E. Cooperation of both agencies has been assured in obtaining easements or permits for necessary state proprietary interest to carry out the project. The U.S. Forest Service also has general plans for campgrounds and further recreational development in this vicinity.

Plumas County has cooperated in providing preliminary plans and engineering data for the area, and by resolution has agreed to accept operation and maintenance responsibility if the project is constructed. The County on December 3 agreed to handling construction on a reimbursement basis under Section 1350 of the Fish and Game Code.

A favorable recommendation on the proposed project has been given by the Department of Fish and Game and by the staff.

Plumas County, by handling construction on a reimbursement basis, can build the project very economically, Mr. Nesbit stated. Mr. Luevano clarified the agenda item as written by pointing out that the project proposed was recommended as feasible but was more economical to construct it on a time and material basis by contract with the county. Mr. Nesbit confirmed that cost estimates presented would be higher if construction was done other than by county contract. He felt that the hiring of local labor would enable the county to do the job for the amount requested. Mrs. Davis pointed out that Plumas County has an unemployment situation which could be relieved by having the county do the work on a reimbursement basis. This was corroborated by Mr. James F. Flanagan, Plumas County Engineer.

Mr. Lowrey voiced the opinion that because of the wonderful fishery, this project would be a most attractive and economical project, regardless of whether or not the project were constructed with local labor.

The possibility of securing matching federal funds, possibly under the public works acceleration act, was discussed; however, it was brought out that previously budgeted projects may not qualify for these funds.

### 9. Crescent City Coastal Angling Access, Del Norte County

\$56,400.00

Mr. Nesbit advised that the Crescent City access project was approved by the Board and allocations were made on April 30, 1958, and September 23, 1959. Total expenditures for this project were \$63,588.35.

The project was completed and has been in full use for more than three years. Since it is the only public coastal launching facility between Eureka and the Oregon border, a distance of over 100 miles, it has proven to be very popular. It is used almost exclusively by fishermen, especially salmon fishermen who fish in the ocean. During peak use days long lines of boats and trailers await launching and parking. No overflow parking is available nearby. Unlike most WCB fishing access facilities, the boats launched here are out for from eight to 12 hours of fishing.

The Crescent City Harbor District has advised that the use could be approximately doubled with additional parking. The only parking area available is made by bulkheading and filling as was done on the original project. The District submitted plans and specifications to do this. The State already has the land under lease until 1983 so no further State land interest is necessary.

The Harbor District has given assurance that the costs will not exceed their estimate and that if a bid within this estimate is not received they will pay the additional cost or reduce the design.

The proposal is to extend the filled parking area another 20,000 square feet which would about double the project's present capacity. In addition to parking, the bulkhead provides the necessary approach to deep water so that boats can be launched at all tides.

Cost estimates have been provided by the Harbor District Engineer and reviewed by the Department of Fish and Game engineering section.

The Executive Officer recommended that the enlargement of this project be approved and that \$56,400 be allocated for this purpose. Mr. Al Wheelon, Del Norte County Engineer, was called upon to substantiate or add to the presentation made by Mr. Nesbit. Mr. Wheelon stated the access project is the finest launching facility on the coast. He introduced Mr. Miller, Harbor District Commissioner, and his son Stephen, and Mr. Pat Hanraty of the Chamber of Commerce. With the additional space created in the filling and bulkheading process, the launching capacity would be doubled.

#### 10. Eagle Lake Angling Access, Lassen County

At the August 7, 1958, meeting, the Board approved a project aimed at the preservation of the Eagle Lake trout and the re-establishment of a fishery in this large body of water. The project consisted of the construction of facilities on Pine Creek, a tributary to Eagle Lake, to collect eggs from the native trout, and the enlargement of the Crystal Lake Hatchery to raise the fingerlings for stocking. These facilities are operated by the Department of Fish and Game.

It is now a well-known fact that this project has been highly successful, that the distinctive Eagle Lake trout has been saved from extinction, and that the fishery has been re-established.

There presently exists a need for boat access to the lake to assist the sportsmen in enjoying the fine fishing now available. This need has been expressed by the County of Lassen Board of Supervisors, by Assemblywoman Pauline Davis, Senator Stanley Arnold, and by resolution of the Shasta-Cascade Wonderland Association.

Through the efforts of the County, the necessary land, now owned by private individuals, will be made available without charge to the State. The project has been designed by the Engineering Section of the Department of Fish and Game and has been reviewed and approved by the County.

This project would be maintained by the County and kept free to the public. The Department of Fish and Game manages the fishery in Eagle Lake and points out in their recommendation that access is needed in this part of the lake. Mr. Nesbit recommended this project be approved and that \$41,000 be allocated for its construction. He introduced Mr. William White, Planning Director for the County of Lassen. Mr. White conveyed the warm regards of the Lassen County Board of Supervisors and their regret for not being able to attend the meeting. He produced a magazine in which was featured a story of the fabulous fishing in Eagle Lake. He also presented letters from the following organizations, who endorsed the project and supported the county's request for an access project in the northwest side of the lake:

Lassen County Chamber of Commerce, P.O. Box 338, Susanville, California

In the discussion it was brought out that the Eagle Lake trout being reared at Crystal Lake Hatchery had also been affected by the disease outbreak at the hatchery this summer. Dr. Calhoun stated a very intensive research program has been initiated to eliminate the disease. If at any time it is felt necessary, the Eagle Lake trout would be moved to another hatchery so that this program would not be affected. Assemblywoman Davis requested that she be kept informed on the progress made in controlling this disease at Crystal Lake.

Senator Stanley Arnold remarked that he is confident the problem will be solved. He added that Eagle Lake is now well-known with a fishery that has been re-established and asked the Board's approval of the needed access.

#### 11. Chico Landing Angling Access, Butte County

The Wildlife Conservation Board in 1957 allocated funds for construction of an angling access facility on the Sacramento River at the mouth of Chico Creek. This project was held in abeyance pending Corps of Engineers! levee work in the area. It now appears more practical to move the proposed project to an alternate site. The Chico Area Recreation and Park District has proposed a new site at Chico Landing approximately one mile north of Chico Creek. This site is on a slough about 700 feet from the river and adjacent to a county road. The location is well protected and a ramp should be usable at even the higher stages of river flow. The development would include a single lane ramp, approximately 1 acre of parking, one-half of which would be paved and the other half graveled, a concrete pad for loading and two chemical type sanitary facilities. The Board of Directors of the Chico Area Recreation and Park District has passed a resolution favoring the development and agreeing to maintain it and keep it open and free to the public. The land upon which the facility would be located is owned by Butte County. The County Board of Supervisors has passed a resolution agreeing to provide the State with a long term free lease.

The Department of Fish and Game has given a fishery recommendation and points out that this project would provide access to salmon and steelhead fishing in the river as well as warmwater fishing.

Plans and cost estimates have been prepared by the Department of Fish and Game Engineering Section. Cost estimates are as follows:

The Executive Officer explained that this was true not only because of the rising cost of construction, but also because through experience the staff has found it important to have quality facilities to turn over to the local agencies for operation and maintenance.

Mr. Larry Seifert of the Chico Area Recreation and Park District and Mr. Gordon Casamajor, a member of the Board of Directors, advised that Butte County has found it a desirable project and requested the Board's favorable consideration.

## 12. Vacaville Game Farm (California Medical Facility), Solano County \$41,250.00

Mr. Nesbit explained that this proposal by the Department of Fish and Game would consolidate state game farm operations for Northern California at the California Medical Facility at Vacaville.

The move is based on experience gained in Southern California, where the Los Serranos Game Farm at Chino has been transferred to the Chino Institution for Men. Use of immate labor in the pheasant rearing program there has been extremely successful with a considerable reduction in costs, and at the same time serving as a useful rehabilitation measure for immates.

For similar benefits, it is now planned to transfer the Yountville Game Farm operations to the Vacaville institution of the Department of Corrections. In addition to therapeutic and rehabilitation values to the inmates, there will be a substantial savings in construction and operating cost to the Department of Fish and Game.

The proposed facilities at Vacaville will be sufficient to rear 25,000 monthold pheasants and 10,000 other exotic game birds annually. The month-old pheasants are supplied to sportsmen's pens in Northern and Central California and the exotic game birds are to be released in various game deficient areas throughout the state in attempts to establish new game populations.

The Department's plans for the plant consist of 180 breeder pens; 60 colony brooder houses; 36 exotic game bird rearing pens; 1 building 30' x 100' to house the exotic game bird breeding cages; 1 building 20' x 80' for office, egg storage and incubator room; and 1 building 20' x 80' for shop and equipment storage. The facility would occupy approximately 10 acres and would be located on Department of Corrections property.

Construction of the game farm will be under the supervision of the California Medical Facility Superintendent and Departmental representatives.

Mr. Nesbit recommended the approval of this project because of the ultimate savings to be realized in the game farm operations, as well as the contribution that can be made in the rehabilitation of prisoners at the Vacaville Facility.

Dr. Wm. C. Keating, Superintendent of the Medical Facility in Vacaville, advised that the Vacaville Facility is prepared and able to assist the Department of Fish and Game to make this project a success. The land, already owned by the State, and the needed manpower for the project are available.

The question of comparative costs and the resultant savings was brought up by Assemblywoman Davis. Mr. James Leiby, Administrative Officer, presented charts showing this, and it was determined that a savings of \$1.15 per bird could be made by moving the operations to the medical facility.

Mr. Elser commented that this is a program in which he is very much interested and which, he felt, would grow. The propagation of game birds, including chukar and quail, can become feasible by getting production costs down.

The following telegram from Senator Luther E. Gibson was received by Mr. Nesbit.

### 13. Ramer Lake Public Fishing Area - Imperial County

This 275 acre lake was built in 1954 with a \$54,600 allocation from the Wildlife Conservation Board on Department of Fish and Game property to provide waterfowl hunting and warmwater fishing. The lake produced fine warmwater fishing for several years but has become progressively poorer until it now produces very little fishing.

Department of Fish and Game fisheries personnel have studied the lake and believe the water quality may be the major problem. The water supply is almost entirely irrigation drain water, and its quality has declined in recent years evidently due largely to increased use of agricultural chemicals.

A fresh water supply from the end of a nearby supply ditch is available. This supply varies from day to day and although it is not a steady flow it would supply the necessary fresh water into the lake if a control structure and ditch is constructed to make that diversion.

After the new water diversion is made the lake would be stocked to re-establish the fishery.

Bogus Creek is located in northern Siskiyou County and enters the Klamath River just below Iron Gate Dam. A natural falls 20 feet high is located 3.5 miles above the mouth. The Department proposes that a ladder be constructed over these falls which would make available an additional mile and one-half of spawning area suitable for salmon and 92 miles suitable for steelhead. This additional stream area is estimated to be capable of handling 700 king salmon, 500 silver salmon, and 2,000 steelhead spawners. The 3.5 miles of stream now available to anadromous fish is heavily utilized, having had an estimated 4,000 king salmon spawners in 1962.

The Department has been interested in constructing a ladder over these falls for many years; however, they had been unable to obtain an easement satisfactory to both the State and the landowners until recently. The completed

easement as well as other documents have been reviewed and approved by the Department of Finance. As consideration for granting the easement the landowners have requested gravel and a cattle guard for the road to the falls which will be used for construction and maintenance of the ladder.

tles, countles, and other Three miles upstream from the falls is a small dam, which at present would create an additional block to fish; however, the owner is rebuilding this dam in a way which will provide passage for fish.

Plans have been prepared by the Department of Fish and Game engineering section to construct a 21 pool rock masonry ladder in the most feasible location. Work would be done by inmates from a Division of Forestry Conservation Camp.

## 18. Point Loma Pier, San Diego County - Status Report

Mr. Elser advised the status of the Point Loma Pier negotiations is that decisions are to be made in Washington, D. C. at the top level -- the final decision probably to be made by the Secretary of the Navy and Secretary of the Interior -- as to whether or not the pier will be saved for public fishing.
