The following project was suggested for cancellation and the balance of \$3,865.00 recovered.

Punta Gorda Coastal Angling Access - Humboldt County

An allocation of \$4,000.00 was made by the WCB on February 14, 1961, for the purchase of 22.8 acres of surplus federal land at the abandoned Punta Gorda Light Station 10 miles southwest of Petrolia. At that time the General Service Administration was making this parcel available at a price within the allocation. Purchase was since deferred by the G.S.A. We have recently been notified that this land has been transferred to the Bureau of Land Management and will be developed for recreation or classified under the Recreation and Public Purposes Act by the federal government. The action of the WCB in 1961 has been instrumental in focusing attention on this valuable land and its retention in public ownership for recreation purposes.

5. Recovery of Reserves

Mr. Nesbit advised that the Board on several occasions set aside reserves for development in certain areas. In recent years the Board has not continued this practice, but certain "reserve funds" remain. This money can be used for projects when needed if recoveries are made.

On October 14, 1950, the Board established a reserve of \$197,684 for the Colorado River area. At the June 6, 1951, meeting, the Board reduced the amount to \$50,000. Subsequent project allocations from this reserve have reduced it to \$23,219.30.

On October 9, 1958, the Board set aside \$100,000 for the Upper American River development. None of these funds were used since other means of financing by the development agency were utilized.

It was recommended by Mr. Nesbit that the \$23,219.30 be recovered and the Colorado River reserve fund be closed. He further recommended that the \$100,000 be recovered from the Upper American River reserve fund and that the fund be closed.

IT WAS MOVED BY ASSEMBLYMAN BELOTTI, SECONDED BY ASSEMBLYWOMAN DAVIS, THAT THE JOINT INTERIM COMMITTEE RECOMMEND THE WILDLIFE CONSERVATION BOARD RECOVER THE FUNDS SET UP IN A RESERVE FOR THE UPPER AMERICAN RIVER DEVELOPMENT (\$100,000.00) AND THE COLORADO RIVER RECREATIONAL DEVELOPMENT (\$23,219.30), AND THAT THE SUM TOTALING \$123,219.30 BE RESTORED TO THE WILDLIFE RESTORATION FUND.

PASSED UNANIMOUSLY.

IT WAS MOVED BY MR. SHANNON, SECONDED BY MR. LUEVANO, THAT THE WILDLIFE CONSERVATION BOARD RECOVER THE FUNDS SET UP IN A RESERVE FOR THE UPPER AMERICAN RIVER DEVELOPMENT (\$100,000.00) AND THE COLORADO RIVER RECREATIONAL DEVELOPMENT (\$23,219.30) AND THAT THE SUM TOTALING \$123,219.30 BE RESTORED TO THE WILDLIFE RESTORATION FUND.

PASSED UNANIMOUSLY.

Mr. Nesbit mentioned that by recovering the balances from projects and reserves, the total sum now available for allocation is \$691,943.46.

6. Accelerated Public Works Program

Mr. Nesbit reviewed the requirements of the Accelerated Public Works Program as related to the Wildlife Conservation Board program which are substantially as follows:

1. Project location must be in eligible counties of

Del Norte Fresno Humboldt Lassen Mendocino Plumas San Benito San Diego San Joaquin Shasta Sierra Siskiyou Stanislaus Trinity

- 2. Projects must not have been budgeted through June 30, 1963.
- 3. Funds cannot be utilized for land acquisition or fish hatcheries.
- 4. Initial obligation of funds must be made by April 1, 1963.
- 5. Labor must be employed on site by June 30, 1963.
- 6. Project must be 50% completed within one year; 100% completed within two years of Federal approval.

At the meeting of January 31, 1963, the Board authorized a reply to the Federal government expressing interest in participating in the Accelerated Public Works program on a matching fund basis, up to an initial amount of \$191,246 in State funds and to an additional amount not to exceed \$100,000 of State funds in the 1962-63 fiscal year.

On March 6, 1963, notification was received from the Department of Interior that an additional \$100,000 in federal funds under the A.P.W. program had been made available to California, supplementing the notification of January 18, 1963, that \$191,246 was available for wildlife conservation projects.

Mr. Nesbit related that the requirements particularly the timing, precluded consideration of projects which included land or easement acquisition, water rights, or major engineering design. However, 11 proposals, agenda items 7 through 17, are presented for Board consideration in coordination with the Accelerated Public Works program. It was mentioned that if all projects were approved by the Board, they would utilize approximately \$278,070 of the available \$291,246 in federal matching funds.

Mr. Luevano stated the requirements of the A.P.W. program were quite complex. Requirement No. 2 as set forth by Mr. Nesbit, is a requirement that projects must not have been budgeted through June 30, 1963. To be assured that WCB participation in this program is legal from the State's standpoint, Mr. Luevano informed the Board that he has requested the assistance of the Administrative Adviser's office. He felt it would be in order for the Board

to proceed, keeping in mind the need for this legal determination. Mr. Smith, the chairman, voiced the opinion that this area of risk involved would be considered and should be understood by all.

7. Hayfork Falls Fish Ladder, Trinity County

\$49,800.00

The Department of Fish and Game proposed a project to construct a fish ladder over a natural barrier which now prevents migration of fish on Hayfork Creek, Trinity County.

Hayfork Creek is tributary to the South Fork of the Trinity River and enters the Trinity at Hyampom. Approximately thirty miles above the mouth is a natural falls 30 feet high which blocks fish migration. A fishway constructed around the falls would open up 19.8 miles of spawning and nursery area for steelhead on Hayfork Creek and tributaries.

Although some salmon utilize this drainage, the primary benefit would be for steelhead. The Department of Fish and Game believes the 19.8 miles of stream under optimum conditions can add around 3,000 steelhead to the Trinity River steelhead run. The Department plans on planting yearling steelhead above the falls for 3 to 4 years to speed the establishment of a run.

The falls is located on U.S. Forest Service land. The Forest Service has recommended this project and has agreed to provide a Special Use Permit for construction and operation of the ladder.

Plans and cost estimates have been prepared by the Department of Fish and Game Engineering Section and reviewed and approved by staff. The plans specify the vertical baffle design for the fishway which requires a minimum of maintenance and is operable under a wide range of flows without requiring adjustment.

Half the project costs will be eligible for reimbursement from the Federal government under the Accelerated Public Works program.

Mr. Nesbit recommended that this project be approved and that \$49,800.00 be allocated to the Department of Fish and Game from the Wildlife Restoration Fund for construction of the fish ladder and that the Department and staff be authorized to proceed with the project.

BE ALLOCATED FOR ITS CONSTRUCTION, WITH APPROPRIATE REIMBURSEMENT
TO BE REQUESTED FROM THE FEDERAL GOVERNMENT; AND THAT THE DEPARTMENT AND STAFF BE AUTHORIZED TO PROCEED WITH THE PROJECT SUBSTANTIALLY AS PLANNED.

PASSED UNANIMOUSLY.

Mr. Luevano requested clarification of the motion. In the event the legal question turns out to be a real problem, Mr. Luevano wanted to know whether or not these proposals are being recommended and approved as WCB projects subject to the legal determination previously mentioned.

Mr. Smith advised that it was his understanding that these projects are being approved, subject to the Federal requirements.

IT WAS MOVED BY MR. SHANNON, SECONDED BY MR. LUEVANO, THAT THE HAYFORK FALLS FISH LADDER, TRINITY COUNTY, BE APPROVED AS A WCB PROJECT AND SUBMITTED TO THE FEDERAL GOVERNMENT AS A PROJECT UNDER THE PUBLIC WORKS ACCELERATION ACT - PL 87-658; THAT THE SUM OF \$49,800.00 BE ALLOCATED FOR ITS CONSTRUCTION, WITH APPROPRIATE REIMBURSEMENT TO BE REQUESTED FROM THE FEDERAL GOVERNMENT; AND THAT THE DEPARTMENT AND STAFF BE AUTHORIZED TO PROCEED WITH THE PROJECT SUBSTANTIALLY AS PLANNED.

PASSED UNANIMOUSLY.

8. Cock Robin Island Access, Humboldt County

\$63,800.00

Mr. Nesbit reported that Humboldt County submitted this proposal for providing angler and hunter access to the lower Eel River about 10 miles south of Eureka.

Humboldt County has submitted this proposal for providing angler and hunter access to the lower Eel River about 10 miles south of Eureka.

Cock Robin Island is located in the Eel River approximately 2 miles from its mouth. Access to the proposed development on County-owned land would be over a bridge recently reconstructed by the County at considerable expense. Public access in this area is limited. The proposed facilities would provide access for anglers to the Eel River and considerable lagoon and bay area at its mouth, as well as some coastal access. Waterfowl hunting on nearby State-owned lands would also be made more available.

Humboldt County would provide the project site through a long-term free lease to the State, and would maintain the facilities.

The Department of Fish and Game recommends the proposal and states that the project would provide anglers with the opportunity to harvest salmon, crab, surf fish and many other types of sport fish.

Preliminary plans and cost estimates have been prepared by the Humboldt County Department of Public Works and have been reviewed and approved by staff.

Mr. Nesbit added that one-half the project costs will be eligible for reimbursement from the Federal government under the Accelerated Public Works Program. He recommended approval of this project.

IT WAS MOVED BY ASSEMBLYMAN BELOTTI, SECONDED BY ASSEMBLY-WOMAN DAVIS, THAT THE JOINT INTERIM COMMITTEE RECOMMEND THE COCK ROBIN ISLAND ACCESS, HUMBOLDT COUNTY, BE APPROVED AS A WCB PROJECT AND SUBMITTED TO THE FEDERAL GOVERNMENT AS A PROJECT UNDER THE FUBLIC WORKS ACCELERATION ACT - PL 87-658; THAT THE SUM OF \$63,800.00 IS HEREBY ALLOCATED FOR ITS CONSTRUCTION, WITH APPROPRIATE REIMBURSEMENT TO BE REQUESTED FROM THE FEDERAL GOVERNMENT; AND THAT THE DEPARTMENT AND STAFF BE AUTHORIZED TO PROCEED WITH THE PROJECT SUBSTANTIALLY AS PLANNED.

PASSED UNANIMOUSLY.

IT WAS MOVED BY MR. SHANNON, SECONDED BY MR. LUEVANO, THAT THE COCK ROBIN ISLAND ACCESS, HUMBOLDT COUNTY, BE APPROVED AS A WCB PROJECT AND SUBMITTED TO THE FEDERAL GOVERNMENT AS A PROJECT UNDER THE PUBLIC WORKS ACCELERATION ACT - PL 87-658; THAT THE SUM OF \$63,800.00 IS HEREBY ALLOCATED FOR ITS CONSTRUCTION, WITH APPROPRIATE REIMBURSEMENT TO BE REQUESTED FROM THE FEDERAL GOVERNMENT; AND THAT THE DEPARTMENT AND STAFF BE AUTHORIZED TO PROCEED WITH THE PROJECT SUBSTANTIALLY AS PLANNED.

PASSED UNANIMOUSLY.

Mr. Shannon said it was his understanding that all of these AFW projects had been planned by the staff as potential projects and that their planning and construction would be accelerated by the Federal program. Mr. Nesbit substantiated this understanding.

Mr. Luevano and Assemblywoman Davis both agreed that the projects to be considered in this program must not be "make work" projects, and that the projects would actually be undertaken by the WCB at some future time.

Rather than hold these projects for construction two or four years hence, the program will enable these to be constructed now.

Mr. Smith suggested that all of the projects which are approved might be covered by a statement in the form of a motion that although these are being approved for immediate construction with Federal government participation, these projects are considered for construction in our master plan.

Assemblyman Belotti introduced Supervisor Sam Mitchell of Humboldt County and members of the Board of Supervisors of Mendocino County, Chairman Joe Scaramella, Joe Hartley, and Harvey Sawyers.

9. Fresno Slough Angling Access, Fresno County \$40,000.00

Mr. Nesbit next presented the Fresno Slough Angling Access project which was proposed by the Department of Fish and Game with support of local organizations.

Fresno Slough is a slough of about 600 surface acres that extends southerly from Mendota Pool and provides good fishing for warmwater species. Much of the slough is within the Mendota Waterfowl Management Area which was purchased and developed by the WCB. The area is open to fishing but is lacking in facilities for public use.

The proposed project would provide parking, boat launching, sanitary and water supply facilities. The site is on undeveloped State land that is part of the Mendota Waterfowl Management Area. Maintenance would be by the Department.

Waterfowl and pheasant hunters would utilize the development during hunting season, in addition to use by fishermen and other recreationists. The annual use figure (25,000) would probably be increased with the added parking to be considered in this project.

Plans and cost estimates prepared by the engineering section of the Department of Fish and Game have been reviewed and approved by staff. Cost estimates are: was the man signed of the hourselver a sen doose same

10. Hermosa Beach Pier, Los Angeles County

Assemblywoman Davis requested, and the Chairman Mr. Smith approved, the consideration of the Hermosa Beach Pier at this time.

Mr. Nesbit explained that the City of Hermosa Beach has taken some positive steps toward a sport fishing pier development program.

Although the project is for a new pier, piers are not new to Hermosa Beach. From 1914 and for 43 years, the City was renowned for its fishing pier, but age and obsolescence required its removal in 1957.

Hermosa Beach has a population of 17,000 people in a 1.3 square mile area. They are, however, hosts to millions from the adjacent metropolitan areas who come to enjoy their beaches and fine fishing.

The City to date has spent nearly \$250,000 obtaining the additional pier site, parking areas and for site clearance. They are confident they can match funds under the WCB policy for a new pier estimated to cost approximately \$600,000, or \$300,000 for each agency.

This agenda item was not a request for an allocation, but rather a preview of a proposed project. If a study indicates this proposal is feasible and funds are available, the project could be presented at an early meeting.

Assemblyman Chapel appeared on behalf of the project. He introduced City Manager Walter Harris, Mayor Frank E. Sasine, City Engineer John Stevens, all of Hermosa Beach, and Mr. George Difani, representing sportsmen's clubs.

Assemblyman Chapel reported the vast majority of the residents of Hermosa Beach were in favor of the pier. He pointed out, however, that there are several residents who do not want the pier and believe the beach should be kept for more exclusive use by local citizens. He hoped favorable consideration would be given to the project and requested expeditious action on this proposal.

Mr. Smith, after discussion with the Board staff and members, advised Assemblyman Chapel that upon completion of the feasibility study which would take approximately two months, the proposal will again be submitted to the Board for consideration and allocation of funds. Mr. Smith was hopeful this would be within 90 days if the conclusions of the feasibility study were favorable.

11. Smith River Angling Access, Del Norte County

\$49,640.00

Senator Quick and Assemblyman Belotti asked that Item 16 on the agenda, the Smith River Angling Access, be considered next. It was pointed out that Senator Collier was present and would like to speak in behalf of the proposal before he had to leave for his other appointments. Assemblyman Belotti introduced Mr. Al Wheelon from Crescent City who was representing the County of Del Norte.

This project was proposed by the County of Del Norte. The Smith River is an excellent salmon and steelhead stream on the northern California coast near the Oregon border. The lower stretches of the river flow through private lands which restrict access. There are no public facilities for boat launching and fishing on the river and only limited commercial facilities on the lagoon at the mouth.

For approximately 2 years staff has been working cooperatively with Del Norte County to locate an available site suitable for a public fishing access development. Recently an appraisal was received on a desirable site, and the landowners are willing to sell for the appraised value. The 3 *acre site is 5 miles upstream from the mouth, and fronts on both a County road and the river in a good fishing location.

Plans and cost estimates for development have been prepared by the County of Del Norte and reviewed and approved by Fish and Game engineering section and staff. Cost estimates are:

Staff cannot be sure of land acquisition and development proceeding rapidly enough to meet AFW program requirements, but believe there is reasonable probability in view of advanced stages of negotiation and planning. If the project meets AFW requirements, half the development costs would be reimbursed by the Federal government.

It was the recommendation of the staff that the project be approved and funds for property acquisition and development be allocated.

It was Mr. Nesbit's recommendation that this project, because of the private acquisition of land involved, be built entirely with WCB funding if APW approval is not received. He pointed out that compliance with APW requirements might be difficult because of time required to purchase land.

12. Luffenholtz Creek Beach Coastal Angling Access, Humboldt County \$27,300.00

Mr. Nesbit reported that the Division of Highways has declared surplus and made available a 7.42 acre parcel of land on the ocean about one mile south of Trinidad. The site includes ocean frontage of approximately 1/3 mile and in addition provides access to public tidelands for some distance to the north and south; above the high tide mark it is bounded on both sides by private property. The parcel is easily available to the public and is located on a county road within several minutes drive of Highway 101. The Division of Highways has indicated that the property could be acquired for the appraised value of \$7,500.00.

The proposed development would include parking area for 75 cars, sanitary facilities, and a trail to the beach on each side of the point.

Although no public use facilities are available and access to the beach is hazardous, considerable use is now being made of this area. The Department of Fish and Game states in its favorable recommendation that Luffenholtz Creek Beach is one of the most popular surf netting areas along the California coast. Both surf smelt and night smelt are taken here as well as surf perch, greenlings, lingcod, cabezon and rockfish. Department surveys indicate that during a five month period in 1958, 9300 angler days of use were expended on this beach, 7700 of which were for surf smelt and the remainder on shore fishing.

Plans and cost estimates have been prepared by the Department of Public Works, Humboldt County, and reviewed and approved by staff. Maintenance of the project facilities would be by the County of Humboldt.

Under the AFW program, one half of the project costs other than land acquisition will be eligible for reimbursement from the Federal government.

13. McCain Valley Hunting Access Project, San Diego County

\$97,000.00

Mr. Nesbit submitted for Board consideration the McCain Valley Hunting Access Project which has been proposed by the Department of Fish and Game and has the support of the Bureau of Land Management, the Board of Supervisors of San Diego County, and sportsmen's organizations in the County.

The McCain Valley Management Area is one of the several National Cooperative Land and Wildlife Management areas which have been withdrawn from sale and established by the Department of Interior at the request of Fish and Game. These withdrawal areas generally provide important opportunity for wildlife management and related recreation, in addition to continuing economic uses where appropriate, such as mining, stock grazing and lumbering.

The McCain Valley Management Area consists of some 38,000 acres located approximately 60 miles east of San Diego, on the eastern slope of the Laguna Mountains. Most of the area is good upland game habitat producing valley and mountain quail, dove and rabbits. Low numbers of deer also range throughout the area, and some chukars and bighorn sheep are present.

This large tract of public land offers considerable potential for public hunting and outdoor recreation, which currently is very limited because of access problems. Most existing roads or jeep trails into the area are blocked by private land surrounding or interspersed with the public lands.

The proposed project calls for construction of a main access road starting from the end of a county road that extends to the edge of the public land about 2 miles north of the town of Boulevard on Highway 80. The planned road would extend northerly and westerly approximately 13 miles on public land through the main part of the management area. Several existing roads and jeep trails would be intercepted that would serve as secondary roads.

In addition, minimum basic facilities are proposed to meet sanitation and water supply needs for hunters and similar recreationists that will be utilizing the area.

Plans and cost estimates prepared by the Bureau of Land Management with assistance by the Department of Fish and Game, have been reviewed and approved by staff. Cost estimates are as follows:

The United States Bureau of Land Management has agreed to assume maintenance of completed developments, as well as handle construction through agreement with the State.

The Bureau also plans to augment the proposed access development as federal funds become available, by extending the main access road and by additional facilities for camping and recreational use.

This project will be eligible for 50% reimbursement of costs if approved by the Federal government as an Accelerated Public Works project.

Staff recommendation on this project was for approval and allocation of \$97,000 for development and for authorization to enter into cooperative agreements with the U.S. Bureau of Land Management to carry out the project.

14. Cinder Cone Hunting Access Project, Shasta County

The next access project in the Cinder Cone area in Shasta County presented by Mr. Nesbit for WCB consideration was proposed by the Bureau of Land Management.

The Cinder Cone National Land and Wildlife Management Area consists of approximately 28,000 acres of land in eastern Shasta County. The area provides hunting for deer and upland game, including mountain and valley quail, doves, cottontail rabbits and gray squirrels.

Public access within the Cinder Cone area is limited. County roads extending southerly from Fall River Mills and Pittville run along the eastern and western boundaries of the area, approximately 6 airline miles apart.

The proposed project is to construct an east-west road about 7 miles in length through the public land, starting about 3 miles south of Fall River Mills and connecting at each end with the existing County roads. This would permit much greater use of the area for hunting and other public recreation. Minimum basic facilities needed for sanitation and water supply also are proposed, to enable hunters and other recreationists to camp.

Plans and cost estimates prepared by the Bureau of Land Management have been reviewed and approved by staff and the engineering section of the Department of Fish and Game. Cost estimates are as follows:

The Bureau of Land Management has agreed to handle construction of the road and to maintain it upon completion. The Bureau states that additional recreational facilities will be provided in the future with federal funds.

Under the Accelerated Public Works program, half of the project costs will be eligible for reimbursement from the Federal government.

This project has been recommended by the Department of Fish and Game and also carried staff recommendation for approval and allocation of funds for development. It was further requested that the staff and the Department be authorized to enter into cooperative agreements with the Bureau of Land Management to carry out this project.

15. Cow Mountain Hunting Access Project, Mendocino County

\$97,700.00

Mr. Nesbit next submitted for Board consideration the Cow Mountain Hunting Access Project which was proposed by the Bureau of Land Management and which will extend and improve the Cow Mountain access road. This project carries the support of the Department of Fish and Game, Mendocino County, and sportsmen's organizations.

The Cow Mountain public recreation area consists of approximately 87,000 acres of BIM lands in eastern Mendocino and western Lake counties which were withdrawn by act of Congress in 1927. The two counties assumed jurisdiction over these lands and in 1952 entered into agreements with the Department of Fish and Game for management.

At the March 16, 1962, meeting, the Board approved a project to build approximately $2\frac{1}{2}$ miles of hunting access road over acquired State land into the western portion of Cow Mountain and allocated \$25,000 therefor. Mendocino County started work on the road last fall, and it should be completed by summer of this year. The primary objective of this road was to enable sportsmen to get into the edge of the public land area, to solve a long-standing problem of access being blocked by private lands.

In the past year since the Board project was approved, the Bureau of Land Management has assumed primary management responsibility for the Cow Mountain area and is developing an overall management plan. Part of this plan is a road network to permit greater public use and improved management of the area.

The new transportation plan for the area calls for extending the WCB road northerly and westerly for a total length of about 15 miles. The general plan is to connect with the end of a recreational road being constructed from

Highway 20 southerly along the east side of Lake Mendocino by the Corps of Engineers.

The present proposal is to carry out part of the overall plan by extending the WCB road approximately 5 miles northerly to enable sportsmen to reach more hunting area as well as give better hunter distribution. Additional area suitable for camping also would be reached and minimum basic facilities for sanitation and water supply developed.

The Bureau of Land Management would construct the project under agreement with the State and also would assume maintenance of the completed development. The Bureau also plans to carry out construction of the other half of the road loop and to provide additional recreational facilities as federal funds are available.

Plans and cost estimates provided by the Bureau of Land Management with the assistance of the Department have been reviewed and approved by Fish and Game engineering and by staff. Cost estimates are as follows:

16. Sheldon Creek Hunting Access Project, Mendocino County

\$18,000.00

Mr. Nesbit advised that this access project was proposed by the Bureau of Land Management and has the support of local government.

The proposed project will improve public access to approximately 5,000 acres of public domain land in southeastern Mendocino County. The Highland Springs county road passes through a portion of this public land, but the narrow road in steep terrain does not permit people to park and utilize the area for its deer and upland game hunting potential. Private lands block entry at other points. A spur road with attendant public use facilities is proposed to enable the area to be utilized by sportsmen and recreationists.

Plans and cost estimates provided by the Bureau of Land Management have been reviewed and approved by staff.

The Department of Fish and Game favorably recommends this project.

The Bureau of Land Management has agreed to carry out project development under cooperative agreement and to maintain the completed facilities.

Under the Accelerated Public Works program, 50% of project costs will be eligible for reimbursement by the Federal government.

Mr. Nesbit recommended project approval and allocation of \$18,000 for development, and that staff and the Department be authorized to enter into cooperative agreements with BIM to carry out the project.

17. Caspar Creek Fish Counting Weir, Mendocino County

\$50,000.00

The Department of Fish and Game proposed this project to construct a fish counting weir on Caspar Creek, Mendocino County, to be used as part of a joint Federal-State study of logging and road building in relation to natural resource management, including salmon and steelhead management in coastal streams.

The California Division of Forestry and the Pacific Southwest Forest and Range Experiment Station of the U.S. Forest Service with assistance from the State Department of Water Resources and the University of California are undertaking a cooperative study of 12 to 15 years' duration on the Caspar Creek drainage of the Jackson State Forest near Ft. Bragg. This study is designed to provide methods and knowledge which will better enable resource management agencies and users to wisely manage and utilize the forest, land, and water resources of the North Coast area. The study will determine the differences between stream flow, sedimentation and other key factors in two watersheds or forks of Caspar Creek. One fork of the stream will be left undisturbed and the other logged, utilizing various types of logging and road building practices. Access roads, stream flow gaging stations, rain gages, and other equipment for the study have been constructed or installed.

This study can also provide answers to the relationship of carefully controlled logging and road building to the production of salmon and steelhead. Data which become available through this study would provide valuable information upon which to base the management of the fisheries resources of the North Coast in relation to logging and road building practices. It could further lead to establishment of improved practices that would result in less damage to the fisheries and other resources as well.

For study purposes, three weirs for measuring flows and/or counting fish are necessary. Two of these weirs, one on the test fork area and one on the undisturbed control fork, have been constructed by the Division of Forestry.

The third weir, proposed here for construction by the WCB, is needed nearer the mouth of the stream to determine total fish populations and production. The weir would be located on State land within the Jackson State Forest.

The weir proposed for construction is considered essential to the success of any fisheries evaluation to be made under this cooperative study. It is expected that upon completion of the study, the weir would be used for periodic counts of adult fish and could with some modification be used for egg-taking purposes, if necessary.

Under the APW program, half of the project costs will be eligible for reimbursement from the Federal government.

The Executive Officer, Mr. Nesbit, recommended that this project be approved and that \$50,000.00 be allocated from the Wildlife Restoration Fund to the Department of Fish and Game and that the Department and WCB staff be authorized to proceed with the project.

18. Heeser Drive Coastal Angling Access, Mendocino County \$15,400.00

Senator Petersen was introduced and a request was made to consider at this time the Heeser Drive Coastal Access, a project in which the Senator was very much interested.

Mr. Nesbit informed the Board that the County of Mendocino has proposed construction of improved sanitary facilities at this popular coastal access west of Mendocino City. The project includes 19 acres of land with $1\frac{1}{2}$ miles of coastline acquired in 1957 with a Board allocation of \$8,700. Initial development consisting of an access road, parking areas, walkways, and chemical toilets was completed in 1960 from a Board allocation of \$23,600.

The project received 9,000 man days use in its first year of operation, 1961, and use is mounting steadily as it becomes better known. In view of the heavy use developing, providing improved sanitary facilities is highly desirable. Maintenance would be handled by Mendocino County under existing agreement.

Plans and cost estimates for permanent type restrooms have been prepared by the engineering section of the Department of Fish and Game and reviewed and approved by staff. Cost estimates are as follows:

One-half the project costs would be eligible for reimbursement by the Federal government if approved as an APW project.

Mr. Nesbit recommended that the project be approved and \$15,400.00 be allocated for construction, and that staff and the Department be authorized to proceed with the project.

19. Lake Level Maintenance Dams Pardoe, Black Rock, Long and Shriner Lakes, Amador County

\$18,100.00

The Chairman, Mr. Smith, advised that this project is not be considered under the Accelerated Public Works program.

Mr. Nesbit advised that this proposal will improve fish habitat by increasing the depth of the lakes. This project to improve four lakes in Amador County and provide additional fishing waters by the construction of small rock-masonry lake level maintenance dams was proposed by interested sportsmen and the Department of Fish and Game.

The four lakes proposed for development are located in the popular and heavily utilized Silver Lake area of the Eldorado National Forest at elevations of from 6,800 to 8,000 feet. One of the four lakes does not support fish life due to shallowness and the other three are subjected to fish loss during the winter. Factors associated with ice cover result in oxygen depletion and subsequent loss of fish. Increasing the depth and volume of these lakes would eliminate or significantly reduce winter kill of fish in three of the lakes and make possible a fishery in the fourth.

Pardoe Lake

This small lake which now contains no fish would be enlarged from about 2 to 3.5 surface acres, with a dam 40 feet long and 5 feet high.

Black Rock Lake

This lake would be enlarged from an estimated 3.4 to 4 surface acres with a 5 foot high, 40 foot long dam and a smaller saddle dam.

Shriner Lake

An increase from about 2.9 surface acres to 3.5 surface acres would be accomplished with a 5 foot high, 100 foot long dam.

Long Lake

This lake would be enlarged from 5 to 7.5 surface acres with a 100 foot long, 3 foot high dam and a smaller saddle dam.

The Division of Forestry has indicated willingness to undertake this project utilizing inmate labor under the Division of Forestry Conservation Camp program. Construction crews would be based at field camps to be set up in the area. The U. S. Forest Service has agreed to provide the necessary use permits and will apply for the water rights. The Department of Fish and Game will provide technical advice as needed to the Division of Forestry.

Cost estimates prepared by the Division of Forestry and the Department of Fish and Game for the four lakes have been reviewed and approved by staff are as follows:

It was Mr. Nesbit's recommendation that this project be approved, that \$18,100.00 be allocated to the Department of Fish and Game from the Wildlife Restoration Fund for construction of the dams, and that the Department and staff be authorized to proceed with the project.

Mr. Nesbit commented that the construction work contemplated will be done in compliance with Forest Service requirements, so that the structure will be compatible with the surroundings. He added that there are probably 50 or 60 possible dam sites throughout California, mostly in the Sierras, that would lend themselves to this type of habitat improvement work. Although the work presented here is not actually a pilot project, if the four dams are successfully and economically completed, we might well have a program to bring before the Board.

Mr. Dana Abell, representing the Sierra Club, requested that this project be delayed until a study could be made to determine whether or not the excellent camping potential adjacent to Shriner Lake would be preserved, even with the increase of the lake depth. The Sierra Club members had expressed concern that the recreational potential there might be lost if the level of the lake were raised as the camping area is below the 5 ft. line.

Senator Begovich stated he is very familiar with the area and felt there was ample camping sites adjacent to this lake. Mr. Luevano asked if the recreational potential at Shriner Lake was an element of consideration in the preliminary surveys. Mr. Mahoney, Field Agent of the Wildlife Conservation Board staff, advised this matter was considered and said there would be adequate camping area available at the site, even if the lake is raised to the 5 ft. level. The Forest Service is very much interested in and cognizant of camping potentials of a lake, and has supported this project.

Mr. Smith expressed appreciation for Mr. Abell's presentation in behalf of the Sierra Club, but added that from testimony heard, it appeared the matter of adequate camping area at Shriner Lake had been thoroughly investigated and cleared by those who are responsible for this phase of recreation.

PASSED UNANIMOUSLY.

20. Consideration of Proposals for Deer Range Improvement

Mr. Nesbit advised that proposals for deer range improvement by selective brush cutting were received in connection with the APW program and great interest was shown in this program. None of these range improvement projects was put on the agenda for this meeting, however, and Mr. Nesbit felt an explanation was in order. In studying these proposals and in comparing costs, it was apparent that range improvement programs of this type would only be practical with the use of inmate labor.

IT WAS MOVED BY ASSEMBLYWOMAN DAVIS, SECONDED BY SENATOR BEGOVICH, THAT THE DEER RANGE IMPROVEMENT PROGRAM OF THE WILDLIFE CONSERVATION BOARD UTILIZE INMATE LABOR AND THAT PROPOSALS ARE TO BE PROCESSED ON THIS BASIS AND PRESENTED FOR BOARD CONSIDERATION AT A FUTURE MEETING.

PASSED UNANIMOUSLY.

Mr. Cecil Phipps, President of the California Wildlife Federation, advised that a number of member clubs have expressed an interest in and have, in fact, started range improvement projects, financed primarily with county fine moneys. It was suggested that the Board might give consideration to a nominal annual allocation for what might be termed a matching fund to implement a range improvement program by sportsmen's clubs. Mr. Phipps asked if the staff could be requested to study the feasibility of such a program and report back at a later date. He felt that if an annual appropriation was made for this program, various clubs could come to the Board for small amounts to finance these projects.

IT WAS MOVED BY ASSEMBLYMAN BELOTTI, SECONDED BY MR. SHANNON, AS A JOINT MOTION, THAT THE WILDLIFE CONSERVATION BOARD STAFF STUDY THE PROBLEM OF COOPERATING WITH COUNTIES OR SPORTSMEN'S GROUPS IN THE PROGRAM OF DEER RANGE IMPROVEMENT UTILIZING MATCHING FUNDS WHICH THEY MIGHT MAKE AVAILABLE THROUGH ANY SOURCE. THE STUDY WILL CONSIDER THE DESIRABILITY AND PROPRIETY OF THIS TYPE OF PROGRAM IN RELATION TO THE OVERALL AND LONG-

RANGE WCB PROGRAM, AND A REPORT WILL BE MADE OF THE FIND-INGS AT A FUTURE MEETING.

PASSED UNANIMOUSLY.

21. South Fork Eel River Tributaries Stream Clearance, Humboldt Co. \$18,100.00

Mr. Nesbit related that this project is a continuation of the stream clearance program approved by the Wildlife Conservation Board in September, 1960.

Proposed for clearance under this project are portions of 43 miles of streams in southern Humboldt County. These streams are Sprowl, Salmon, Seeley, Elk, Dean, Miller, Bridge, Durphy, China, Sawmill and Chadd creeks. All except Chadd Creek are tributary to the South Fork Eel River, which has important runs of king salmon, silver salmon and steelhead. Chadd Creek is tributary to the main Eel River. The proposed project will open up additional fish habitat now blocked by logging debris and in addition will improve areas now available to fish.

Detailed surveys of these streams have been made by the Department of Fish and Game which has also investigated responsibility for the log jams. It has been determined that existing owners have no legal responsibility to remove the jams.

Clearance work would be carried out by immate labor from the Division of Forestry's High Rock Conservation Camp. The work schedule is estimated for three years, with two years of clearance work and one of follow-up.

Point Loma Fishing Pier Proposal

In compliance with earlier instructions of the Board, Mr. Nesbit stated that Mr. Elser and he had proceeded with negotiations to save the construction pier at Point Loma for public fishing use. These negotiations resulted in a very favorable conclusion which is best summarized in the letter dated January 29, 1963, from President John F. Kennedy to Governor Brown. The text of this letter is quoted below.

"Dear Governor Brown:

"On January 18, the Under Secretary of the Navy, the Honorable Paul B. Fay, Jr., met with Mr. William Elser, a member of the California Fish and Game Commission, to discuss the Point Loma fishing pier situation in San Diego. It is my understanding that the following points of agreement resulted from this meeting:

"The Navy will create an electronics platform in the form of a large ship drawn from the Reserve Fleet. This platform will be anchored approximately 3,000 feet off Point Loma and several thousand feet north of the existing outfall sewer trestle. A rock breakwater will be constructed to seaward of this electronics platform. A pier will be constructed to connect the land with the electronics platform. This proposed pier will consist of a rock causeway for one-third of its length, and a floating pier the remainder of the distance.

"When the pier is completed, the Navy will allow fishing from it on Saturdays, Sundays and holidays. On occasions when the Naval Electronics Laboratory is conducting experimental work, this privilege will be denied.

"The Department of Defense's proposed Budget, now before the Congress includes approximately \$5.5 million to cover the initial construction costs of this pier. Since this is a solid and well-justified requirement, we anticipate no problem in obtaining Congressional approval. It is recommended, however, that you retain your option to purchase the existing sewer trestle, or scaffold, until we can be assured of the final Congressional position. We should be able to inform you of this position no later than the end of August this year.

FURTHER, that this resolution be made a part of the official minutes of this Board and that a copy of this resolution be furnished Senator Johnson.

Resolution Honoring Assemblyman Lloyd Lowrey

WHEREAS, Assemblyman Lloyd Lowrey has left the Legislature after 22 years of service to his State;

WHEREAS, Assemblyman Lowrey was one of the founders of the Wildlife Conservation Board and a member of the Legislative Advisory Committee of this Board since its inception in 1947;

WHEREAS, Assemblyman Lowrey, through his efforts and leadership on this Board and in the Legislature, has advanced the cause of wildlife conservation bringing about the unparalleled program which we now have:

NOW THEREFORE, be it resolved that we, the members of the Wildlife Conservation Board, the Joint Interim Committee and the Board staff convey to Assemblyman Lowrey our sincere appreciation for his contributions to the work of the Board; and

FURTHER, that this resolution be made a part of the official minutes of this Board and that a copy of this resolution be furnished Assemblyman Lowrey.

25. Request for Staff Investigation of Ruth Lake, Trinity County

Assemblyman Belotti requested staff to look into the possibility of WCB participation in an access project at Ruth Lake to see if it would be within the scope of the Board program and to report back at a future meeting.

26. Accelerated Public Works Program -- Overall Authorization

Chairman Smith pointed out that the various projects approved were planned for consideration under the normal Board program, but that these projects, if APW approval is received, will be accelerated from their present scheduling.

Mr. Shannon noted that this agenda contained a number of projects in the northern part of the State. He explained that one of the requirements under the APW program is that projects must be in an area considered depressed -- only one southern California county is in that category. The WCB, therefore, is able to secure matching funds for projects only in those counties, but that the program would release like WCB funds for allocation to other counties which are not considered depressed.

IT WAS MOVED BY MR. SHANNON, SECONDED BY ASSEMBLYMAN BELOTTI, AS A JOINT MOTION, THAT THE ACCELERATED PUBLIC WORKS PROJECTS AS PRESENTED, WITH THE EXCEPTION OF THE SMITH RIVER PROJECT, ARE APPROVED BY THE BOARD SUBJECT TO THE APPROVAL AND PARTICIPATION OF THE FEDERAL GOVERNMENT UNDER THE PUBLIC WORKS ACCELERATION ACT - PL 87-658.

PASSED UNANIMOUSLY.

There being no further business, the meeting was adjourned at 11:00 a.m.
